Dear Mr. Astourian:

Pursuant to the provisions of the Glendale Municipal Code, Title 30, Chapter 30.49, the Community Development Department has processed your application for an administrative use permit to allow the sales, service, and on-site consumption of alcoholic beverages at an existing full-service restaurant in the "IMU" – Industrial/Commercial Mixed Use Zone, located at **4441 San Fernando Road,** described as Portion of Lot 10, Watts' Subdivision, in the City of Glendale, County of Los Angeles.

CODE REQUIRES

(1) The sales, service and on-site consumption of alcoholic beverages requires an Administrative Use Permit in the IMU – Industrial/Commercial Mixed Use Zone.

APPLICANT'S PROPOSAL

(1) To allow the on-site sales, service, and consumption of alcoholic beverages (Type 47) at an existing full-service restaurant.

ENVIRONMENTAL RECOMMENDATION

The project is exempt from CEQA review as a Class 1 "Existing Facilities" exemption, pursuant to State CEQA Guidelines Section 15301.

After considering the evidence presented with respect to this application, the Director of Community Development has **APPROVED WITH CONDITIONS** your request based on the following findings:

REQUIRED/MANDATED FINDINGS

After thorough consideration of the statements contained in the application, the plans submitted therewith, the above analysis by Community Development Department staff, and any comments received from the public with respect to this application, this Administrative Use Permit application is approved based on the following:

A. That the proposed use will be consistent with the various elements and objectives of the general plan.

The subject site is located in the IMU Zone and the General Plan Land Use Element designation is Mixed Use. Goods and services offered in this zone generally attract clientele from the adjoining residential neighborhoods as well as the surrounding community. The sales, service and on-site consumption of alcoholic beverages within an existing restaurant at this location is appropriate in an area of the city zoned for mixed-use development including commercial and residential uses and will continue to provide an option for the dining public to enjoy alcoholic beverages with their meals.

The on-site sales, service and consumption of all-types of alcoholic beverages at the restaurant will be consistent with the elements and objectives of the General Plan. The land use designation of the site is Mixed Use where retail services along major arterials, such as San Fernando Road, are desired. The project site is already developed and the applicant's request is to allow the on-site sales, service and consumption of alcoholic beverages at the existing full-service restaurant. Currently, the existing restaurant is operating with Conditional Use Permit Case No. PCUP 2011-013 for the on-site sales, service and consumption of beer and wine. The applicant's request is for an Administrative Use Permit to expand the ancillary use to include all types of alcoholic beverages (beer, wine and distilled spirits) for on-site sales, service and consumption at the existing full-service restaurant, "Old Gyumri". The restaurant is surrounded by other complementary businesses, including commercial and industrial uses. The Land Use Element is most directly related to the approval of this use. All other elements of the General Plan, including Open Space, Recreation, Housing, and Noise Elements, will not be impacted as a result of the applicant's request. The project site is fully developed and has not been slated for open space or recreation, or for new housing. The proposal to add alcoholic beverage sales for on-site consumption will be ancillary to the existing primary use, a full-service restaurant, and as such, is not anticipated to increase the existing noise levels above and beyond the current conditions. This application does not include any new floor area or modifications to the existing building; therefore, there will be no increase in required parking for the use. Adequate utilities, landscaping, and traffic circulation measures are already provided.

B. That the use and its associated structures and facilities will not be detrimental to the public health or safety, the general welfare, or the environment.

The on-site sales, service, and consumption of all types of alcoholic beverages at the existing full-service restaurant, "Old Gyumri", will not be detrimental to the health, safety and public welfare of the neighborhood in general. According to the Glendale Police Department, the subject property is located in Census Tract 3024.01, where the suggested limit for on-sale alcohol establishments is five. Currently, there are nine on-sale establishments located in this tract, including "Old Gyumri", currently operating with a Type 41 ABC license for on-site sales, service and consumption of beer and wine. Based on Part 1 crime statistics for this census tract, in 2016 there were 550 crimes, which is above the citywide average of 194. This census encompasses San Fernando Road to Maple Street and a portion of South Brand to the east. While this census tract has more crime than in many other areas of the city, it includes large retail establishments (e.g., drug stores/pharmacies, supermarkets, etc.) and multi-family uses, which tend to have a higher crime rate compared to lower density residential and smaller retailers, which typify much of the city. In addition, this portion of south Glendale is within close proximity to the city's boundary limits between Glendale and Los Angeles.

Within the last calendar year, there was one call for police service at this location that required a field investigation of two males, but this did not result in a report being taken. The Police Department's suggested conditions are included in this approval to mitigate and ensure that there are no negative impacts to the public health, safety, general welfare, or the environment.

C. That the use and facilities will not adversely affect or conflict with adjacent uses or impede the normal development of surrounding property.

It is not anticipated that the on-site sales, service and consumption of alcoholic beverages at the existing full-service restaurant will be detrimental to the community or adversely conflict with the community's normal development. Since 1998, "Old Gyumri" has operated without any major incident. The applicant's request to allow the on-site sales, service and consumption of alcoholic beverages with meals is not anticipated to adversely conflict with surrounding properties as it will be ancillary to the primary use, a full-service restaurant. The subject property is surrounded by other complementary businesses, including commercial and industrial uses with residential neighborhoods located in the vicinity.

While there are no public facilities located within the immediate area (500' radius) of the subject site, there is one park, and two churches located near the project site in the City of Los Angeles: Chevy Chase Park and Recreation Center, located at 4165 Chevy Chase Drive (0.3 miles to the west), House of Faith Evangelical Church, located at 4160 Chevy Chase Drive (0.3 miles to the west), and Cristo Rey Church, located at 4343 Perlita Avenue (0.4 miles to the southwest). While these facilities and uses are nearby, they are outside the immediate vicinity and given the nature of consumption of alcoholic beverages with meal service, it is not anticipated that the applicant's request will impede their existing operations. Suggested conditions of approval made by the Police Department have been incorporated in the staff recommendation, to ensure that any potential negative impacts will be appropriately mitigated.

The Circulation Element identifies San Fernando Road as a major arterial street, and West Chevy Chase Drive as a minor arterial street. These streets are fully developed and can adequately handle the existing traffic circulation around the site. The project site is surrounded by properties zoned for mixed use development. The applicant's request to serve all types of alcoholic beverages with meals is not anticipated to create any negative traffic-related impacts along West Chevy Chase Drive and San Fernando Road, and other businesses over and above the existing conditions. The restaurant, "Old Gyumri", has been in operation at this location since 1998 without any major incident.

D. That adequate public and private facilities such as utilities, landscaping, parking spaces and traffic circulation measures are or will be provided for the proposed use.

The applicant's request to allow the service of all types of alcoholic beverages at the existing full-service restaurant will not result in inadequate public or private facilities. The project site is already developed and associated facilities are existing. The full-service restaurant, "Old Gyumri", has been operating at this location since 1998 and serving beer and wine with meals since 1999. The existing on-site parking has proven to meet the parking demand of the development, and has not resulted in conflicts with nearby businesses or residential development. As identified in the Circulation Element, both San Fernando Road and West

Chevy Chase Drive are fully developed streets and can adequately handle the existing traffic circulation adjacent to the site.

REQUIRED ADDITIONAL FINDINGS OF FACT FOR AN AUP FOR ALCOHOL SALES, SERVICE AND CONSUMPTION

That all the criteria set forth in Section 30.49.030 (E) to be considered in making the findings in subsection a. through d. above have all been met and thoroughly considered:

- 1) That where an existing or proposed on-site use is located in a census tract with more than the recommended maximum concentration of on-site uses or that where an existing or proposed off-site use is located in a census tract with more than the recommended maximum concentration of off-site uses, both as recommended by the California Department of Alcoholic Beverage Control, such use does not or will not tend to intensify or otherwise contribute to the adverse impacts on the surrounding area caused by such over concentration based on the comments submitted by the City of Glendale Police Department. The sale of alcoholic beverages for on-site consumption that is incidental to food service at the existing restaurant site does not, or will not, tend to encourage or intensify crime within this reporting district as noted in Finding B above.
- 2) That where the existing or proposed use is located in a crime reporting district with a crime rate which exceeds 20 percent of the city average for Part 1 crimes, as reported by the Glendale Police Department, such use does not or will not tend to encourage or intensify crime within the district because conditions have been included in the approval of this application to ensure that any potential negative impacts will be appropriately mitigated. As noted in Finding B above, the crime rate in Census Tract 3024.01 is above city average for Part 1 crimes. No evidence has been presented that would indicate that the on-site sales, service and consumption of alcoholic beverages at the subject site would encourage or intensify crime within the district. Suggested conditions of approval from the Police Department have been incorporated into the staff recommendation and will mitigate any potential negative impacts.
- 3) That the existing or proposed use does not or will not adversely impact any other uses within the surrounding area (church, public or private school or college, day care facility, public park, library, hospital or residential use). As noted in Finding C above, these uses are not within the immediate vicinity (500' radius). However, there is one park and two churches located nearby in the City of Los Angeles. While these facilities and uses are nearby, given the nature of the consumption of alcoholic beverages with meal service as an ancillary service, it is not anticipated that the applicant's request will impede their existing operations.
- 4) That adequate parking and loading facilities are or will be provided for the existing or proposed use or other reasonable alternatives satisfy the transportation and parking needs of the existing or proposed use. As noted in Findings C and D above, the applicant's request is not anticipated to increase the need for public or private facilities. The ancillary service of alcoholic beverages at the existing full-service restaurant, "Old Gyumri" is not anticipated to intensify traffic circulation or parking demand. The site is fully developed and adequate parking and loading facilities are currently provided.
- 5) That, notwithstanding consideration of the criteria in subsections 1 through 4 above, alcoholic beverage sales, service and on-site consumption does serve a public

convenience for the area. The applicant's request to allow the on-site sales, service and consumption of all types of alcoholic beverages at an existing full-service restaurant does serve a public convenience because it serves local residents, businesses, and the surrounding community. Conditions placed on the approval of the project will ensure that it will not adversely impact nearby businesses and residential uses.

CONDITIONS OF APPROVAL

APPROVAL of this Administrative Use Permit shall be subject to the following conditions:

- That the development shall be in substantial accord with the plans submitted with the application except for any modifications as may be required to meet specific code standards or other conditions stipulated herein to the satisfaction of the Director of Community Development.
- That all necessary licenses, approvals and permits as required from Federal, State, County or City authorities including the City Clerk shall be obtained and kept current at all times.
- That sufficient measures shall be enforced to effectively eliminate interior and exterior loitering, parking congestion, disturbing noise, disturbing light, loud conversation, and criminal activities.
- 4. That the premises shall maintain a bona fide restaurant and shall provide a menu containing an assortment of foods normally offered in such restaurant. Food service shall be available at all times and in all areas of the premises during normal operating hours.
- 5. That there shall be no bar or lounge area upon the premises maintained solely for the purpose of sales, service or consumption of alcoholic beverages by patrons.
- 6. That the service of alcoholic beverages shall be in full accord with the regulations and conditions established by the State Department of Alcoholic Beverage Control.
- 7. That the premises shall be maintained in a clean and orderly condition, free of weeds, trash, and graffiti.
- 8. That all signs displayed shall conform to the requirements of the Glendale Municipal Code.
- 9. That any expansion or modification of the facility or use which intensifies the existing business shall require a new Administrative Use Permit application. Expansion shall constitute adding floor area, increased hours of operation, changes to the use or operation, or any physical change as determined by the Director of Community Development.
- 10. That no alcoholic beverages shall be sold to be taken from the premises by patrons for off-site consumption.

- 11. That no patrons of the restaurant shall be allowed to bring into the establishment any alcoholic beverages that were purchased from outside of the establishment, unless the facility has an established corkage policy allowing and regulating such.
- 12. That at all times when the premises are open for business, the service of alcoholic beverages shall be made only in the areas as designated with the ABC license.
- 13. That the restaurant shall remain open to the public during business hours.
- 14. That the proprietor and his/her employees shall make an active and conscientious effort to keep customers and employees from trespassing on other nearby properties or otherwise making disturbances in the area.
- 15. That the front and back doors to the restaurant shall be kept closed at all times while the location is open for business, except in case of emergency.
- 16. That there shall be no video machine(s) maintained on the premises.
- 17. That music or noise shall be contained within the edifice of the establishment. The business shall comply with the state and local news and ordinances concerning excessive noise and disturbing the peace.
- 18. That access to the premises shall be made available to all City of Glendale Planning and Neighborhood Services Division, Police Department, and Fire Department staff upon request for the purpose of verifying compliance with all laws and conditions of this approval.
- 19. That the restaurant adhere to the City's Fresh Air Ordinance, Title 15, Chapter 8.52 of the Glendale Municipal Code.
- 20. That no exterior signs advertising the service of alcoholic beverages shall be permitted.
- 21. That live entertainment is permitted with the exception that no karaoke, no bikini activities or events, no lingerie activities or events, no swimwear activities or events, nor any similar activities or events be allowed where partial clothing of male or female entertainment is provided. A Live Entertainment permit must be obtained in accordance with G.M.C 5.60.
- 22. That a Business Registration Certificate be applied for and issued for a full-service restaurant with the on-site sales, service and consumption of alcoholic beverages, subject to the findings and conditions outlined in this decision letter.
- 23. That authorization granted herein shall be valid for a period of **TEN (10) YEARS UNTIL JUNE 29, 2027.**

APPEAL PERIOD, TIME LIMITS, LAPSE OF PRIVILEGES, TIME EXTENSIONS

The applicant's attention is called to the fact that this grant is not a permit or license and that any permits and licenses required by law must be obtained from the proper City and public agency.

Under the provisions of the Glendale Municipal Code, Title 30, Chapter 30.62, any person affected by the above decision has the right to appeal said decision to the Planning Commission if it is believed that the decision is in error or that procedural errors have occurred, or if there is substantial new evidence which could not have been reasonably presented. It is strongly advised that appeals be filed early during the appeal period and in person so that imperfections/incompleteness may be corrected before the appeal period expires. Any appeal must be filed on the prescribed forms within fifteen (15) days following the actual date of the decision. Information regarding appeals and appeal forms will be provided by the Permit Services Center (PSC) or the Community Development Department (CDD) upon request and must be filed with the prescribed fee prior to expiration of the 15-day period, on or before JULY 14, 2017 at the Permit Services Center (PSC), 633 East Broadway, Room 101, Monday thru Friday 7:00 am to 12:00 pm, or at the Community Development Department (CDD), 633 East Broadway, Room 103, Monday thru Friday 12:00 pm to 5 pm.

TRANSFERABILITY

This authorization runs with the land or the use for which it was intended for and approved. In the event the property is to be leased, rented or occupied by any person or corporation other than yourself, it is incumbent that you advise them regarding the conditions and/or limitations of this grant.

VIOLATIONS OF THESE CONDITIONS

Violations of conditions required by this determination may constitute a misdemeanor or infraction under section 1.20.010 of the Glendale Municipal Code (GMC) and/or a violation of other local, State or Federal laws or regulations. Unless a specific penalty is provided, any person convicted of a misdemeanor shall be punished by a fine not to exceed one thousand dollars (\$1,000.00), or imprisonment for a term not to exceed six (6) months, or by both fine and imprisonment. Infractions are punishable by a fine not exceeding the sum of five hundred dollars (\$500.00) for each violation. Violations of conditions required by this determination may be grounds for a revocation.

REVOCATION, CONTINUING JURISDICTION

Section 30.64.020 – Revocation – The Community Development Department shall have continuing jurisdiction over variances, administrative use permits, and conditional use permits (individual cases heard and decided upon by the Planning Hearing Officer).

To consider the revocation, the Planning Hearing Officer shall hold a public hearing after giving notice by the same procedure as for consideration of a conditional use permit at least ten (10) days' notice by mail to the applicant or permittee. Continuing jurisdiction over any case is the purview of the Planning Hearing Officer, with concurrence by the Director of Community Development.

GMC CHAPTER 30.41 PROVIDES FOR

<u>TERMINATION</u>: Every right or privilege authorized by an administrative use permit shall terminate two (2) years after the granting of such, unless the exercise of such right or privilege has commenced in good faith prior to such time, except as otherwise provided for.

<u>CESSATION:</u> An Administrative Exception may be terminated by the review authority upon any interruption or cessation of the use permitted by the Administrative Exception for one year or more in the continuous exercise in good faith of such right and privilege.

<u>EXTENSION</u>: An extension of the administrative use permit may be requested one time and extended for up to a maximum of one (1) additional year upon receipt of a written request from the applicant and demonstration that a reasonable effort to act on such right and privilege has commenced within the two (2) years of the approval date. In granting such extension the applicable review authority shall make a written finding that neighborhood conditions have not substantially changed since the granting of the administrative use permit.

NOTICE - subsequent contacts with this office

The applicant is further advised that all subsequent contacts with this office regarding this determination must be with the Case Planner first and then, the Hearing Officer who acted on this case. This would include clarification, verification of condition compliance and plans or building permit applications, etc., and shall be accomplished **BY APPOINTMENT ONLY**, in order to assure that you receive service with a minimum amount of waiting. You should advise any consultant representing you of this requirement as well.
