The project will provide a total of 8 parking spaces in private, attached garages and 1 unenclosed guest parking space. The project includes common open space, private open space and landscaping.

**REQUESTED ACTION:** The appellants are requesting that the City Council overturn the Design Review Board decision of July 13, 2017, adopting the Final Mitigated Negative Declaration and approving Design Review Board Case No. PDR 1329554 with conditions.
