### PROJECT DESCRIPTION

Application for an Administrative Use Permit to allow the on-site sales, service, and consumption of beer and wine (Type 41) at an existing full-service restaurant in the C2 (Community Commercial) zone.

## **CODE REQUIRES**

(1) Sales, service and on-site consumption of beer and wine requires an Administrative Use Permit in the C2 – Community Commercial.

# **APPLICANT'S PROPOSAL**

(1) To allow the on-site sales, service, and consumption of beer and wine (Type 41) at an existing full-service restaurant.

## **ENVIRONMENTAL DETERMINATION**

The project is exempt from CEQA review as a Class 1 "Existing Facilities" exemption, pursuant to State CEQA Guidelines Section 15301(e), because the discretionary permit request is to allow beer and wine sales for on-site consumption at an existing restaurant and there is no expansion of the existing use proposed beyond its existing conditions.
