PROJECT DESCRIPTION: To construct a new two-story, approximately 5,400 square-foot single-family, contemporary-styled residence and an attached three-car garage on a 27,734 square-foot lot in the R1R, District II zone. A swimming pool, outdoor kitchen, detached bathroom and covered outdoor living room are also proposed to be constructed. The existing 2,792 square-foot, single-family residence (built in 1957), garage and swimming pool will be demolished as a result of the project. An appeal has been filed of the Design Review Board's March 1, 2018 approval of the project with conditions.

REQUESTED ACTION: The appellant is requesting that the City Council overturn the Design Review Board decision of March 1st, 2018 to approve Design Review Board Case No. PDR 1724101.

ENVIRONMENTAL DETERMINATION: The project is exempt from CEQA review as a Class 3 New construction or Conversion of small structures exemption, pursuant to State CEQA Guidelines Section 15303.
