

1) Have a substantial adverse effect on a scenic vista?

No Impact. The project site is located within a heavily urbanized area of the City with relatively flat topography. No scenic vistas, as identified in the Open Space and Conservation Element (January 1993), exist within or in proximity to the project site. Therefore, no impacts to scenic vistas would result from project implementation.

Mitigation Measures: No mitigation measures are required.

2) Substantially damage scenic resources, including, but not limited to, trees, rock outcroppings, and historic buildings within a state scenic highway?

No Impact. No state scenic highway is located adjacent to or within view of the project site. No impacts to scenic resources within a State scenic highway would occur.

Mitigation Measures: No mitigation measures are required.

3) Substantially degrade the existing visual character or quality of the site and its surroundings?

Less Than Significant Impact. The project will be reviewed by the Design Review Board in regards to the site planning, mass and scale, architecture, materials, and landscaping to ensure the project's design is compatible with the surrounding built environment. The design of the development features well-articulated façades with variations in building height to visually minimize the mass and scale, and high quality materials to accentuate the modern design concept. The site planning utilizes common open space to provide adequate separation and landscaping between the new development and the existing structures to be maintained at 401 Hawthorne Street. Impacts to visual character are anticipated to be less than significant given the project review processes, and the location of the lot in a high density residential neighborhood directly adjacent to a three-story parking structure for the regional Glendale Galleria commercial shopping mall.

Mitigation Measures: No mitigation measures are required.

4) **Create a new source of substantial light or glare, which would adversely affect day or nighttime views in the area?**

Less Than Significant Impact. Day and nighttime lighting for the project would slightly increase as a result of the proposed project but would be similar to the existing multi-family uses within the project vicinity. Because the surrounding area is already developed, a large portion of which is multi-family uses and includes the Glendale Galleria parking structure to the east, less than significant impacts associated with lighting are anticipated as a result of the proposed project.

Mitigation Measures: No mitigation measures are required.

1) **Convert Prime Farmland, Unique Farmland, or Farmland of Statewide Importance (Farmland), as shown on the maps prepared pursuant to the Farmland Mapping and Monitoring Program of the California Resources Agency, to non-agricultural use?**

No Impact. There is no prime farmland, unique farmland, or farmland of statewide importance within or adjacent to the proposed project site and no agricultural activities take place on the project site. No agricultural use zone currently exists within the City, nor are any agricultural zones proposed. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

2) Conflict with existing zoning for agricultural use, or a Williamson Act contract?

No Impact. The proposed project site is located in an urbanized area developed with other buildings similar in use, scale, and style to the proposed structure. No portion of the project site is proposed to include agricultural zoning designations or uses, nor do any such uses exist within the City under the current General Plan and zoning. There are no Williamson Act contracts in effect for the project site or surrounding vicinity. No conflicts with existing zoning for agricultural use or Williamson Act contract would result. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

3) Conflict with existing zoning for, or cause rezoning of, forest land (as defined in Public Resources Code section 12220(g)) or timberland (as defined in Public Resources Code section 4526)?

No Impact. There is no existing zoning of forest land or timberland in the City of Glendale. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

4) Result in the loss of forest land or conversion of forest land to non-forest use?

No Impact. There is no forest land within the City of Glendale. No forest land would be converted to non-forest use under the proposed project. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

5) Involve other changes in the existing environment, which, due to their location or nature, could result in conversion of farmland to non-agricultural use or conversion of forest land to non-forest use?

No Impact. There is no farmland or forest land in the vicinity of or on the proposed project site. No farmland would be converted to non-agricultural use and no forest land would be converted to non-forest use under the proposed project. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

1) ***Conflict with or obstruct implementation of the applicable air quality plan?***

Less Than Significant Impact. The South Coast Air Quality Management District (SCAQMD) adopted an updated air quality management plan (AQMP) in March 2017. The 2016 AQMP was prepared to comply with the federal and State Clean Air Acts and amendments; accommodate growth; reduce the high levels of pollutants in the South Coast Air Basin (“Basin”); meet federal and State air quality standards; and minimize the fiscal impact of pollution control measures on the local economy. It builds on approaches in the previous AQMP to achieve attainment of the federal ozone air quality standard. These planning efforts have substantially decreased exposure to unhealthy levels of pollutants, even while substantial population growth has occurred within the Basin.

The Southern California Association of Governments (SCAG) adopted the 2016–2040 Regional Transportation Plan/Sustainable Communities Strategy (2016 RTP/SCS). Projects that are consistent with the projections of population forecasts are considered consistent with the AQMP. Population within the City of Glendale in 2012 and 2040 was forecasted to be 193,200 and 214,000, respectively. The Project would generate approximately 20 net new units, yielding far less than one percent of the anticipated increase in population. The Project would be consistent with the planned land uses and population growth for the City and would not conflict with the AQMP. Therefore, impacts would be less than significant.

Mitigation Measures: No mitigation measures are required.

2) ***Violate any air quality standard or contribute substantially to an existing or projected air quality violation?***

Less Than Significant Impact. The California Emissions Estimator Model (CalEEMod version 2016.3.2) was used to estimate air quality impacts during the construction and operation stages of the project. Results from the model indicate that the proposed project would not exceed thresholds for construction, area, or operational impacts. A summary of the results are attached. No significant impacts are anticipated. Based on the model run, construction of the project would not exceed the SCAQMD thresholds of significance for construction.

Area sources emissions would be generated during the consumption of natural gas for space and water heating devices, by natural gas fireplaces, and during the operation of gasoline-powered landscape maintenance equipment and use of consumer products (e.g., hair spray, deodorants, lighter fluid, air fresheners, automotive products, and household cleaners). Mobile source emissions would be generated by the motor vehicles traveling to and from the project site.

Area and mobile source emissions were estimated using California Emissions Estimator Module (CalEEMod version 2016.3.2). The project’s land uses were entered into the model to estimate area source emissions. It was assumed that all buildings would combust natural gas. Based on the California Emissions Estimator Module (CalEEMod version 2016.3.2) model run, the project would not exceed the SCAQMD thresholds of significance for construction or operations. Therefore, no significant impacts are anticipated.

Mitigation Measures: No mitigation measures are required.

3) ***Result in a cumulatively considerable net increase of any criteria pollutant for which the project region is non-attainment under an applicable federal or state ambient air quality standard (including releasing emission, which exceed quantitative thresholds for ozone precursors)?***

Less Than Significant Impact. As indicated in the air quality model run described above, the proposed project would not result in a cumulatively considerable net increase of any criteria pollutant. No significant impacts would occur.

Mitigation Measures: No mitigation measures are required.

4) **Expose sensitive receptors to substantial pollutant concentrations?**

Less than Significant Impact. As indicated in the model run performed for this project, no construction or operational impacts are anticipated. Therefore, the project would not expose sensitive receptors to a substantial pollutant concentration; impacts are considered less than significant.

Mitigation Measures: No mitigation measures are required.

5) **Create objectionable odors affecting a substantial number of people?**

Less Than Significant Impact. Construction activity associated with the proposed project may generate detectable odors. However, any detectable odors would be associated with initial construction and would be considered short-term. Significant long-term odor impacts are not anticipated to occur from the project since it is a residential use. No significant impacts would occur.

Mitigation Measures: No mitigation measures are required.

- 1) ***Have a substantial adverse effect, either directly or through habitat modifications, on any species identified as a candidate, sensitive, or special status species in local or regional plans, policies, or regulations, or by the California Department of Fish and Game or U.S. Fish and Wildlife Service?***

No Impact. The proposed project is located in an area that has been heavily urbanized for many years. No natural vegetation exists onsite or adjacent to the site. No wildlife species other than those which can tolerate human activity and/or are typically found in urban environments are known to exist onsite. These human-tolerant species are neither sensitive, threatened, nor endangered. Implementation of the project would not result in any impact to species identified as endangered, threatened, sensitive or being of special concern by the California Department of Fish and Game or the United States Fish and Wildlife Service. The site does not provide suitable habitat for endangered or rare species. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

- 2) ***Have a substantial adverse effect on any riparian habitat or other sensitive natural community identified in local or regional plans, policies, regulations or by the California Department of Fish and Game or U.S. Fish and Wildlife Service?***

No Impact. The proposed project is located in an area that has been highly urbanized for many years. No riparian habitat and/or other sensitive natural communities are present within the vicinity, and no such areas are present onsite or adjacent to the project site. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

- 3) ***Have a substantial adverse effect on federally protected wetlands as defined by Section 404 of the Clean Water Act (including, but not limited to, marsh, vernal pool, coastal, etc.) through direct removal, filling, hydrological interruption, or other means?***

No Impact. The proposed project is located in an area that has been heavily urbanized for many years. No federally protected wetlands are present within the vicinity, and no such areas are present onsite or adjacent to the project site. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

- 4) ***Interfere substantially with the movement of any native resident or migratory fish or wildlife species or with established native resident or migratory wildlife corridors, or impede the use of native wildlife nursery sites?***

No Impact. The proposed project is located in an area that has been urbanized for many years and has been substantially modified by human activity. All lots surrounding the subject property have been developed. Implementation of the proposed project will not interfere with the movement of native resident or migratory fish or wildlife species or with established native resident or migratory wildlife corridors, or impede the use of native wildlife nursery sites. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

- 5) ***Conflict with any local policies or ordinances protecting biological resources, such as a tree preservation policy or ordinance?***

No Impact. The proposed project lies within an area that has been heavily urbanized for many years. No protected biological resources are present onsite, as the subject lot and the surrounding area are developed with residential and commercial uses. Similarly, there are no indigenous trees, as defined pursuant to Chapter 12.44 of the Glendale Municipal Code (GMC), located on or within 20 feet of the project site. Implementation of the proposed project will not conflict with any local policy designed to protect biological resources. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

6) **Conflict with the provisions of an adopted Habitat Conservation Plan, Natural Community Conservation Plan, or other approved local, regional, or state habitat conservation plan?**

No Impact. No Habitat Conservation Plan, Natural Community Conservation Plan, or other approved habitat conservation plan has been adopted to include the project site. Therefore, the project would not conflict with any such plans. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

1) **Cause a substantial adverse change in the significance of a historical resource as defined in CEQA Guidelines §15064.5?**

Less Than Significant Impact With Mitigation Incorporated.

The project site consists of three lots that are currently developed with seven detached buildings, featuring a total of five residential units and corresponding parking garages located at 401, 405, and 409 Hawthorne Street. The existing residences are not currently listed on the Glendale Register of Historic Resources, the California Register of Historic Resources, or the National Register of Historic Places. A Historic Building Assessment (HBA) was prepared for the buildings and structures located on the project site by Applied Earthworks, Inc., dated November 2017 (Exhibit #2).

Developed in 1922, the lot at 401 Hawthorne Street features a shared detached-two car garage and two detached residential units: one 1,092 square-foot unit addressed as 401 Hawthorne Street and one 898 square-foot unit addressed as 141 South Columbus Avenue. The structures are designed in the “Clipped Gable Colonial” subtype of the Craftsman style. The HBA determined that this property is individually eligible under Criterion 3 of the Glendale Register of Historic Resources based on the architectural style, and the grouping of the two units and the detached shared garage. As discussed in the project description, all buildings on this site will be retained as part the of development proposal. For this reason, a Preservation Plan was prepared for the property located at 401 Hawthorne Street, dated November 2017 (Exhibit #3). The project’s site plan takes into account the preservation of these existing structures on the lot that are specifically buffered from the new building by a landscaped common open space area.

The lot addressed as 405 Hawthorne Street was developed in 1940 with a 1,323 square-foot duplex and a 360 square-foot detached two-car garage towards the rear, and is a modest example of the Minimal Traditional architecture style. Originally developed in 1910, the lot at 409 Hawthorne Street features a 799 square-foot single-family residence with a 240 square-foot detached garage at that

rear that was rebuilt in 1995. As indicated in the HBA, the existing single-family residence is a modest example of the Hip-Roofed Cottage subtype of the Transitional Craftsman architectural style. The HBA concluded that, based on the relevant historic contexts and an analysis of the eligibility criteria and integrity thresholds for listing in the various historical registers, the properties and structures at 405 and 409 Hawthorne Street are not eligible for historic designation at the national, state, or local level. Therefore, demolition of the existing buildings on these two lots would not be considered a significant impact.

Mitigation Measures: Compliance with the following mitigation measures will reduce potentially significant impacts associated with the buildings/structures located at 401 Hawthorne Street and 141 South Columbus Avenue to less than significant.

CR-1 The applicant shall comply with all of the recommendations outlined in the Preservation Plan prepared by Applied Earthworks, Inc., dated November 2017, to preserve all three structures onsite (401 Hawthorne Street, 141 South Columbus Avenue and shared garage), and shall retain an Architectural Historian who meets the Secretary of the Interior’s Professional Qualification Standards. The Architectural Historian shall work with the Project Architect to implement the conditions of the Preservation Plan to avoid damage to character-defining features.

2) *Cause a substantial adverse change in the significance of an archaeological resource pursuant to CEQA Guidelines §15064.5?*

Less Than Significant Impact. The project site has already been developed and disrupted. Any archaeological resources, which may have existed at one time (on or beneath the site), have likely been previously disturbed. Nonetheless, construction activities associated with project implementation would have the potential to unearth undocumented resources. In the event that archaeological resources are unearthed during project subsurface activities, all earth-disturbing work within a 100-meter radius must be temporarily suspended or redirected until an archaeologist has evaluated the nature and significance of the find. After the find has been appropriately mitigated, work in the area may resume. With implementation of this standard requirement, no significant impact is anticipated.

Mitigation Measures: No mitigation measures are required.

3) *Directly or indirectly destroy a unique paleontological resource or site or unique geologic feature?*

Less Than Significant Impact. The project site has already been subject to disruption and development. Any superficial paleontological resources which may have existed at one time on the project site have likely been previously unearthed by past development activities. Nonetheless, there is a possibility that paleontological resources may exist at deep levels and could be unearthed with implementation of the proposed project. In the event that paleontological resources are unearthed during the proposed project-related subsurface activities, all earth-disturbing work within a 100-meter radius must be temporarily suspended or redirected until a paleontologist has evaluated the nature and significance of the find. After the find has been appropriately mitigated, work in the area may resume. With implementation of this standard requirement, no significant impact is anticipated.

Mitigation Measures: No mitigation measures are required.

4) *Disturb any human remains, including those interred outside of formal cemeteries?*

Less Than Significant Impact. No known burial sites exist within the vicinity of the project site or surrounding area. Nonetheless, if human remains are encountered during excavation and grading activities, State Health and Safety Code Section 7050.5 requires that no further disturbance shall occur until the County coroner has made the necessary findings as to origin and disposition pursuant to Public Resources Code Section 5097.98. If the remains are determined to be of Native American descent, the coroner has 24 hours to notify the Native American Heritage Commission (NAHC). The

NAHC will then contact the most likely descendant of the deceased Native American, who will then serve as a consultant on how to proceed with the remains (i.e., avoid removal or reburial). With implementation of this standard requirement, no significant impact is anticipated.

Mitigation Measures: No mitigation measures are required.

1) **Expose people or structures to potential substantial adverse effects, including the risk of loss, injury, or death involving:**

i) **Rupture of a known earthquake fault, as delineated on the most recent Alquist-Priolo Earthquake Fault Zoning Map issued by the State Geologist for the area or based on other substantial evidence of a known fault? Refer to Division of Mines and Geology Special Publication 42.**

Less Than Significant Impact. The project site is not within an established Alquist-Priolo Fault Zone for surface fault rupture hazards, according to the City’s Safety Element (August 2003). Based on the available geologic data, active or potentially active faults with the potential for surface fault rupture are not known to be located directly beneath or projecting toward the project site. Based on these considerations, the potential for surface ground rupture at the subject site is considered low. Therefore, impacts from the rupture of a seismic fault are considered to be less than significant.

Mitigation Measures: No mitigation measures are required.

ii) **Strong seismic ground shaking?**

Less than Significant Impact. The project site could be subject to strong ground shaking in the event of an earthquake originating along one of the faults listed as active or potentially active in the Southern California area. This hazard exists throughout Southern California and could pose a risk to public safety and property by exposing people, property, or infrastructure to potentially adverse effects, including strong seismic ground shaking. Compliance with applicable building codes would minimize structural damage to buildings and ensure safety in the event of a moderate or major earthquake. Therefore, impacts related to strong seismic ground shaking would be less than significant.

Mitigation Measures: No mitigation measures are required.

iii) **Seismic-related ground failure, including liquefaction?**

No Impact. As identified in the City of Glendale General Plan Safety Element, the project site is not located within a mapped liquefaction hazard zone. Therefore, no impacts related to liquefaction would occur.

Mitigation Measures: No mitigation measures are required.

iv) **Landslides?**

No Impact. As identified in the City of Glendale General Plan Safety Element, the project site is not located within a mapped landslide hazard zone. Therefore, no impacts related to landslides would occur.

Mitigation Measures: No mitigation measures are required.

2) **Result in substantial soil erosion or the loss of topsoil?**

Less Than Significant Impact. Construction activity associated with the proposed project development may result in wind and water driven erosion of soils due to grading activities if soil is stockpiled or exposed during construction. However, this impact is considered short-term in nature since the site would be covered with pavement and landscaping upon completion of construction activity. Further, as part of the proposed project, the applicant would be required to adhere to conditions under the National Pollutant Discharge Elimination System (NPDES) Permit set forth by the Regional Water Quality Control Board (RWQCB), and prepare and submit a Storm Water Pollution Prevention Plan (SWPPP) to be administered throughout construction. The SWPPP would incorporate Best Management Practices (BMPs) to ensure that impacts from erosion during construction would be reduced to less than significant.

Mitigation Measures: No mitigation measures are required.

3) **Be located on a geologic unit or soil that is unstable, or that would become unstable as a result of the project, and potentially result in an onsite or off-site landslide, lateral spreading, subsidence, liquefaction or collapse?**

Less Than Significant Impact. Subsidence is the process of lowering the elevation of an area of the earth's surface and can be caused by tectonic forces deep within the earth or by consolidation and densification of sediments sometimes due to withdrawal of fluids, such as groundwater. The project site is not located in an area of significant subsidence activity and would not include fluid withdrawal or removal. In addition, as indicated in Response F-1 (iii), above, the soil under the project site is not prone to liquefaction. Therefore, impacts related to unstable soils are anticipated to be less than significant.

Mitigation Measures: No mitigation measures are required.

4) **Be located on expansive soil, as defined in Table 18-1-B of the California Building Code (2001), creating substantial risks to life or property?**

Less Than Significant Impact. As identified in Plate 2.1 of the Safety Element of the General Plan, the soils underlying the project site and surrounding area are Alluvium which is unconsolidated floodplain deposits of silt, sand and gravel and is considered to have a low expansion potential. In addition, development of the project will be required to comply with applicable building codes which would minimize structural damage to buildings and ensure safety in the event of a moderate or major earthquake. No significant impacts would occur as a result of the proposed project.

Mitigation Measures: No mitigation measures are required.

5) **Have soils incapable of adequately supporting the use of septic tanks or alternative waste water disposal systems where sewers are not available for the disposal of waste water?**

No Impact. The proposed project site is currently connected to the City's sewer system. No septic tanks will be utilized as part of the project. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

1) **Generate greenhouse gas emissions, either directly or indirectly, that may have a significant impact on the environment?**

Less Than Significant Impact. Greenhouse Gas (GHG) Emissions are said to result in an increase in the earth's average surface temperature commonly referred to as global warming. This rise in global temperature is associated with long-term changes in precipitation, temperature, wind patterns and other elements of the earth's climate system, known as climate change. These changes are now broadly attributed to GHG emissions, particularly those emissions that result from the human production and use of fossil fuels.

Climate changes resulting from GHG emissions could produce an array of adverse environmental impacts including water supply shortages, severe drought, increased flooding, sea level rise, air pollution from increased formation of ground level ozone and particulate matter, ecosystem changes, increased wildfire risk, agricultural impacts, ocean and terrestrial species impacts, among other adverse effects.

In 2006, the State passed the Global Warming Solutions Act of 2006, commonly referred to as AB 32, which set the greenhouse gas emissions reduction goal for the State of California into law. GHG as defined under AB 32 includes: carbon dioxide, methane, nitrous oxide, hydrofluorocarbons, perfluorocarbons, and sulfur hexafluoride. AB 32 requires the California Air Resources Board (CARB), the State agency charged with regulating statewide air quality, to adopt rules and regulations that would achieve greenhouse gas emissions equivalent to statewide levels in 1990 by

2020 by reducing greenhouse gas emissions from significant sources via regulation, market mechanisms, and other actions.

Senate Bill 375 (SB 375), passed in 2008, links transportation and land use planning with global warming. It requires the CARB to set regional targets for the purpose of reducing greenhouse gas emissions from passenger vehicles. Under this law, if regions develop integrated land use, housing and transportation plans that meet SB 375 targets, new projects in these regions can be relieved of certain review requirements under CEQA. The Southern California Association of Governments (SCAG) has prepared the region's Sustainable Communities Strategy (SCS), which is part of the Regional Transportation Plan (RTP). Glendale has an adopted Greener Glendale Plan, which meets regional greenhouse gas reduction targets, as established by SCAG and adopted by the CARB. The Greener Glendale Plan uses land use development patterns, transportation infrastructure investments, transportation measures and other policies that are determined to be feasible to reduce GHG.

At this time, no air agency, including the SCAQMD, has adopted applicable project-level significance thresholds for GHGs emissions. AB 32 did not set a significance threshold for GHG emissions, although EPA, CARB or another agency may issue regulations at some point which may set forth significance criteria for CEQA analysis. In the interim, none of the CEQA Guidelines, the CEQA Air Quality Handbook, the Air Quality Management Plan, or the SCAQMD set forth applicable significance thresholds for GHG emissions.

Due to the complex physical, chemical and atmospheric mechanisms involved in global climate change, there is no basis for concluding that the project's very small and essentially temporary (primarily from construction) increase in emissions could cause a measurable increase in global GHG emissions necessary to force global climate change.

CEQA Guidelines Section 15130(f) clarifies that the effects of GHG emissions are cumulative and should be analyzed in the context of CEQA's requirements for cumulative impact analysis. CEQA Guidelines Section 15064.4 recommends consideration of qualitative factors that may be used in the determination of significance, including the extent to which the project complies with regulations or requirements adopted to implement a reduction or mitigation of GHGs. Per CEQA Guidelines Section 15064(h)(3), a project 's incremental contribution to a cumulative impact can be found not cumulatively considerable if the project will comply with an approved plan or mitigation program that provides specific requirements that will avoid or substantially lessen the cumulative problem within the geographic area of the project. Examples of such programs include "plans or regulations for the reduction of greenhouse gas emissions."

Since this Project is consistent with Greener Glendale Strategies to reduce GHGs and the SCS prepared by SCAG, this project would result in a less than cumulatively considerable impact on GHG emissions and no mitigation is required.

Mitigation Measures: No mitigation measures are required.

2) Conflict with any applicable plan, policy or regulation of an agency adopted for the purpose of reducing the emissions of greenhouse gases?

Less Than Significant Impact. For the reasons discussed in Response G.1 above, the Project would not conflict with an applicable plan, policy or regulation adopted for the purpose of reducing the emissions of greenhouse gases. No significant impacts are anticipated.

Mitigation Measures: No mitigation measures are required.

1) Create a significant hazard to the public or the environment through the routine transport, use, or disposal of hazardous materials?

No Impact. The project involves the development of residential uses. Such uses do not generally involve the routine use, transport, or disposal of significant amounts of hazardous materials. No new hazardous materials will be generated at the site. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

2) Create a significant hazard to the public or the environment through reasonably foreseeable upset and accident conditions involving the release of hazardous materials into the environment?

Less Than Significant Impact. Development of the project site will require the demolition of three existing residential units and associated structures, originally developed in 1910 (409 Hawthorne Street) and 1940 (405 Hawthorne Street). Structures constructed, repaired or remodeled between 1930 and 1981 have the potential of containing Asbestos Containing Building Materials. In addition, buildings constructed prior to 1978 may contain lead based paints. Testing and removal of lead-based paints is subject to regulation established by the Environmental Protection Agency (EPA). The proposed project could create a significant hazard to the public or the environment through

reasonably foreseeable upset and accident conditions involving the release of hazardous materials into the environment. As such, the existing structures are required to be tested in accordance with applicable rules and regulations and remediated accordingly prior to demolition. The project would be required to comply with all applicable rules established by the SCAQMD, including Rule 403 and 402, during the construction phase of the project that would prevent dust from migrating beyond the project site. Compliance with the applicable rules and regulations would ensure that significant impacts are reduced to a less than significant level.

Mitigation Measures: No mitigation measures are required.

3) ***Emit hazardous emissions or handle hazardous or acutely hazardous materials, substances, or waste within one-quarter mile of an existing or proposed school?***

No Impact. There are no existing or proposed schools located within one-quarter (0.25) mile from the project site. The closest schools are Columbus Elementary School (0.5 miles to the north), Pacific Avenue Education Center (0.5 miles to the south), and Thomas Edison Elementary School (0.5 miles to the south). Furthermore, the project would not emit any new hazardous emissions or handle hazardous materials since residential uses are proposed. No impact would occur.

Mitigation Measures: No mitigation measures are required.

4) ***Be located on a site which is included on a list of hazardous materials sites compiled pursuant to Government Code Section 65962.5 and, as a result, would it create a significant hazard to the public or the environment?***

No Impact. The project site is not included on a list of hazardous materials sites compiled pursuant to Government Code Section 65962.5. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

5) ***For a project located within an airport land use plan or, where such a plan has not been adopted, within two miles of a public airport or public use airport, would the project result in a safety hazard for people residing or working in the project site?***

No Impact. The proposed project site is not located within an airport land use plan or within two miles of a public airport or public use airport. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

6) ***For a project within the vicinity of a private airstrip, would the project result in a safety hazard for people residing or working in the project site?***

No Impact. The project site is not within the vicinity of a private airstrip. No impact would occur.

Mitigation Measures: No mitigation measures are required.

7) ***Impair implementation of or physically interfere with an adopted emergency response plan or emergency evacuation plan?***

No Impact. There is no "City Disaster Response Route" located on any streets adjacent to the project site. The nearest designated street is Brand Boulevard, as identified in the City of Glendale General Plan Safety Element (August 2003). The proposed project does not involve any changes to Brand Boulevard and Glenoaks Boulevard, which are the closest City Disaster Response Routes to the project site, nor would the project result in the alteration of an adopted emergency response plan or evacuation plan. As such, no impacts to emergency response plans or emergency evacuation plans would occur as a result of the proposed project.

Mitigation Measures: No mitigation measures are required.

No Impact. The project site and surrounding area are characterized by features typical of the urban landscape. The project site is not within a fire hazard area as identified in the City of Glendale General Plan Safety Element. No impact would occur.

Mitigation Measures: No mitigation measures are required.

1) **Violate any water quality standards or waste discharge requirements?**

Less Than Significant Impact. Under Section 402 of the Clean Water Act, the U.S. Environmental Protection Agency (EPA) has established regulations under the National Pollutant Discharge

Elimination System (NPDES) program to control direct storm water discharges. In City of Glendale, the Los Angeles Regional Water Quality Control Board (RWCQB) administers the NPDES permitting program and is responsible for developing NPDES permitting requirements. The NPDES program regulates industrial pollutant discharges that include construction activities. Implementation of the proposed project will require compliance with all the NPDES requirements including the submittal and certification of plans and details showing both construction and post-construction Best Management Practices (BMPs) that are integrated into the design of the project. The submittal of a Standard Urban Stormwater Mitigation Plan (SUSMP), as approved by the City Engineer, will also be required to be integrated into the design of the project. Therefore, implementation of the proposed project is not expected to violate any water quality standards or waste water discharge requirements since the project will be required to comply with applicable permitting requirements. No significant impacts are anticipated.

Mitigation Measures: No mitigation measures are required.

- 2) ***Substantially deplete groundwater supplies or interfere substantially with groundwater recharge such that there would be a net deficit in aquifer volume or a lowering of the local groundwater table level (e.g., the production rate of pre-existing nearby wells would drop to a level which would not support existing land uses or planned uses for which permits have been granted)?***

Less Than Significant Impact. The proposed project does not involve additions or withdrawals of groundwater. The amount of hardscape proposed on the project site would be more than the current on-site conditions, but will be similar to other multi-family development in the area. The project will provide 4,687 square-feet of landscaped open space. The proposed project would not significantly interfere with the recharge of local groundwater or deplete the groundwater supplies. No significant impacts would occur as a result of the proposed project.

Mitigation Measures: No mitigation measures are required.

- 3) ***Substantially alter the existing drainage pattern of the site or area, including through the alteration of the course of stream or river, in a manner, which would result in substantial erosion or siltation on- or off-site?***

Less Than Significant Impact. The project site is comprised of three flat lots that are developed with a total of five residential units and associated structures. Water that falls on the site either is absorbed into the ground on-site or is directed to Hawthorne Street or South Columbus Avenue. These conditions would not change substantially with project implementation. The project will not alter the course of a stream or river, since no river or stream is located on the site, nor would the project result in a substantial increase in runoff. Impacts to drainage patterns would be less than significant.

Mitigation Measures: No mitigation measures are required.

- 4) ***Substantially alter the existing drainage pattern of the site or area, including through the alteration of the course of a stream or river, or substantially increase the rate or amount of surface runoff in a manner, which would result in flooding on- or off-site?***

Less Than Significant Impact. The proposed project would not alter the course of a stream or river. Flood hazards due to heavy precipitation can result in inundation of developed areas due to overflow of nearby stream courses or from inadequate local storm drain facilities, if not sized to accommodate large storm events. The amount of surface runoff would increase as a result of the project; however, the increase would not be substantial. In addition, no Federal Emergency Management Agency (FEMA)-designated flood zones are located within the project site as indicated in the City of Glendale General Plan Safety Element (August 2003). Therefore, flooding impacts would be less than significant.

Mitigation Measures: No mitigation measures are required.

Less Than Significant Impact. Please refer to Response I-3 above. The amount of impervious surfaces would increase, resulting in an increase in runoff from the site; however, the increase would not be substantial. Impacts from runoff as a result of the proposed project are anticipated to be less than significant.
Mitigation Measures: No mitigation measures are required.

1) *Physically divide an established community?*

Less Than Significant Impact. The project site is comprised of three lots currently developed with two single-story detached units and a detached garage on the easterly lot (401 Hawthorne Avenue), a single-story duplex with a detached garage on the center lot (405 Hawthorne Street), and a single-story single-family dwelling with a detached garage on the westerly lot (409 Hawthorne Street); all existing structures on 405 and 409 Hawthorne Street are to be demolished as part of the project. The proposed project involves the development of a new, 5-story, 23-unit multi-family residential building with the two units at 401 Hawthorne Street being maintained. The net total number of dwelling units on-site will be 20. The project complies with the development standards for the R-1250 zone, except as provided for in their request for a density bonus. The project includes five affordable housing units and is requesting three concessions in regards to floor area ratio, height, and additional outdoor space, in compliance with GMC 30.36 (Density Bonus Incentives). The project site is surrounded by primarily 2- and 3-story multi-family residential structures to the north, west and south, and a three-story parking structure for the nearby Glendale Galleria commercial shopping mall located directly to the east across South Columbus Avenue. Though the proposed building will be the tallest residential building in the immediate high density residential neighborhood, the massing is not significantly incompatible, given the project’s corner location across from the one of the city’s largest parking structures associated with a regional shopping center. The neighboring 3-story residential building directly west of the project site would provide an appropriate transition to the other existing, 2- and 3-story residential developments in the surrounding area. Therefore, less than significant impacts would occur.

Mitigation Measures: No mitigation measures are required.

2) *Conflict with any applicable land use plan, policy, or regulation of an agency with jurisdiction over the project (including, but not limited to the general plan, specific plan, local coastal program, or zoning ordinance) adopted for the purpose of avoiding or mitigating an environmental effect?*

Less Than Significant Impact. The zoning designation on the project site is R-1250 (High Density Residential) Zone and the General Plan designation is High Density Residential. The proposed project complies with the Land Use Element of the General Plan, as well as the zoning standards, except as provided for in the requested density bonus. In exchange for providing five affordable housing units for very low income tenants, and in compliance with GMC 30.36 (Density Bonus Incentives), the developer is requesting three concessions in regards to floor area ratio, height, and additional outdoor space. No variances are proposed. As a result, no significant impacts associated with applicable land use plans and policies would occur.

Mitigation Measures: No mitigation measures are required.

1) ***Exposure of persons to or generation of noise levels in excess of standards established in the local general plan or noise ordinance, or applicable standards of other agencies?***

Less Than Significant Impact. The proposed project involves the construction of a new 23-unit multi-family development and rehabilitation of two residential structures and garage. This type of use is permitted on the subject site. Surrounding land uses include multi-family and commercial uses. As shown in the City’s Noise Element, the project site is located in an area identified as being below the 60-65 dB noise contours. The new project would be constructed to reduce interior noise to acceptable levels as required by the building code. While the proposed building will produce a more intensive use than the existing condition, it is not anticipated to generate noise in excess of the limits contained in the Noise Element. No significant impacts are anticipated.

Mitigation Measures: No mitigation measures are required.

2) ***Exposure of persons to or generation of excessive groundborne vibration or groundborne noise levels?***

Less Than Significant Impact. Excessive groundborne vibration is typically associated with activities such as blasting used in mining operations, or the use of pile drivers during construction. The project would not require any blasting activities and any earth movement associated with project construction is not anticipated to require pile driving. Structural support required for the development of the project would be installed by drilling bore holes, installing steel I-beams, and grouting with concrete. Therefore, the project is not expected to generate excessive groundborne vibration or groundborne noise levels. No significant impacts are anticipated.

Mitigation Measures: No mitigation measures are required.

3) ***A substantial permanent increase in ambient noise levels in the project vicinity above levels existing without the project?***

Less Than Significant Impact. As indicated in Response L-1 above, significant noise impacts are not anticipated to result from the long-term operation of the proposed project.

Mitigation Measures: No mitigation measures are required.

Less Than Significant Impact. Short-term noise impacts could occur as a result of construction activities. All development within the project site will be required to comply with the City of Glendale Noise Ordinance (Municipal Code Chapter 8.36) which prohibits construction activities to between the hours of 7:00 p.m. on one day and 7:00 a.m. of the next day or from 7:00 p.m. on Saturday to 7:00 a.m. on Monday or from 7:00 p.m. preceding a holiday. Compliance with the City’s noise ordinance would ensure that noise impacts will be less than significant.

Mitigation Measures: No mitigation measures are required.

No Impact. The proposed project involves the demolition of three existing residential units, the preservation of two residential units, and the development of a new, 23-unit multi-family project; resulting in a net increase of 20 residential dwelling units. The subject site is zoned R-1250 with a General Plan Land Use Designation of High Density Residential. The subject site is surrounded by other multi-family residential and commercial buildings, with a few remaining single-family residences, and all properties are served by existing roadways and infrastructure. Based on the net increase of 20 units and an average household size of 2.7 residents per dwelling unit, the Project would generate approximately 54 residents, which is within the SCAQ growth projections for

Glendale. The project is consistent with the zoning and land use designation of the area and, therefore, is not considered growth inducing. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

2) **Displace substantial numbers of existing housing, necessitating the construction of replacement housing elsewhere?**

No Impact. The project involves the construction of a 23-unit multi-family residential development with two existing units being maintained. Three existing housing units will be demolished as part of the project. When completed, the project will provide a net increase of 20 additional units. No impacts would occur.

3) **Displace substantial numbers of people, necessitating the construction of replacement housing elsewhere?**

No Impact. The project involves the demolition of the three existing residential units, the maintenance of two existing units, and the development of a new 23-unit multi-family residential building. The total number of net new dwelling units on-site will be 20. According to the submitted Environmental Information Form, the five existing units are currently vacant, and as such will not displace any occupants. No impacts would occur.

Mitigation Measures: No further mitigation measures are required.

a) **Fire protection?**

Less Than Significant Impact. The City of Glendale Fire Department (GFD) provides fire and paramedic services to the project site. The nearest fire station is Station No. 21, located at 421 Oak Street, which is approximately 0.2 miles south from the project site. The project will be required to

comply with the Uniform Fire Code, including installation of fire sprinklers for the new dwelling units, and to submit plans to the Glendale Fire Department at the time building plans are submitted for approval. Impacts to fire protection are anticipated to be less than significant.

Mitigation Measures: No mitigation measures are required.

b) Police protection?

Less Than Significant Impact. The Glendale Police Department (GPD) provides police services to the project site. The nearest police facility is located at 131 North Isabel Street, which is about 0.9 miles from the subject property. The proposed project will add a net gain of 20 residential dwelling units to the area and approximately 54 new residents. The site is located in an urban, developed area of the City. The additional population that this project will bring is anticipated to have less than significant impact to Police services.

Mitigation Measures: No mitigation measures are required.

c) Schools?

Less Than Significant Impact. Section 65995 of the Government Code provides that school districts can collect a fee on a per square foot basis for new residential units or additions to existing units to assist in the construction of or additions to schools. Such fee will be collected prior to the issuance of a building permit. Payment of these fees under the provisions of Government Code Section 65995.5 reduces impacts to less than significant levels.

Mitigation Measures: No mitigation measures are required.

d) Parks?

Less Than Significant Impact. The proposed project would not involve the development or displacement of a park. The subject property and surrounding area is zoned for high density multi-family residential development and was not planned for use as a park. The project would provide landscape areas/open space in the front, side and rear yards, as well as within a common rooftop deck, which will fulfill the landscape/open space requirement per the R-1250 zoning requirements. The project features a total of 6,196 SF of common open space (5,000 SF required; 200 SF per residential unit), 1,807 SF of private open space (920 SF required; 40 SF per unit); 5,903 SF of landscaping (4,687 SF required; 25% of lot area), and 1,360 SF of additional common open space per GMC 30.31.020.A.7 (1,600 SF additional open space required; 900 SF plus 20 SF for each additional foot of lot width exceeding 90 feet). As indicated in the project description, the applicant is requesting a concession in regards to the additional outdoor space requirement, in accordance with GMC Chapter 30.36 and State Density Bonus Law. The proposed project would be subject to the park and library development impact fees. Such fees will be collected prior to the issuance of development permits. With payment of the fee, impacts are considered less than significant.

Mitigation Measures: No mitigation measures are required.

e) Other public facilities?

Less Than Significant Impact. The project site is presently developed with five multi-family residential units. Development of the site will result in a net increase of 20 residential units. The lots surrounding this site are primarily developed with multi-family residential buildings to the north, west and south, and the Glendale Galleria (and associated parking structure) to the east. Public facilities are located within close proximity and walking distance of the project site, the main one being Harvard Mini Park located at 425 West Harvard Street, approximately 0.1 miles to the south, and features approximately 0.29 acres of park area. Pacific Park and Library, located at 501 South Pacific Avenue is approximately 0.6 miles to the southwest and features 5.3 acres of park area. The additional dwelling units that this project will provide can be adequately served by existing public facilities. No significant impacts are anticipated.

Mitigation Measures: No mitigation measures are required.

Less Than Significant Impact. The project, as proposed, is consistent with the Land Use Element, which designates the project site as high density residential. The potential demand for new parks, or increased maintenance and additional improvements at existing parks, would be minimal due to the small net increase of new residential dwelling units. The incremental increase of residents to the city occupying the project's 25 units (net increase of 20 from the existing condition) will not substantially increase the use of the City's community parkland such that any noticeable impact on the community parks within the city will occur.

In addition, pursuant to Section 4.10 of the G.M.C., the applicant will be required to pay public use facilities development impact fees applicable to an affordable housing project. Therefore, the proposed project is not anticipated to result in significant impacts associated with the demand of existing park facilities.

Mitigation Measures: No mitigation measures are required.

Less than Significant Impact. There would be an increase in day-time traffic as a result of the construction activities. However, this increase is not considered substantial since the construction phase is short-term, approximately 18 months.

The proposed project would result in a net increase of 20 residential units above the current conditions, and therefore, would result in a slight increase in the number of vehicles using the area streets. Based upon trip generation factors published in *Trip Generation*, Institute of Transportation Engineers, 9th Edition, 2012, the project would generate fewer than 50 vehicle trips during both the weekday morning peak hour (typically occurring between 7 a.m. and 9 a.m.) and the weekday evening peak hour (typically occurring between 4 p.m. and 6 p.m.). Because the project's peak-hour trip generation would not exceed the established threshold of 50 vehicle trips during peak hours, no significant and adverse impacts on the area street system is anticipated.

Mitigation Measures: No mitigation measures are required.

1) ***Exceed wastewater treatment requirements of the applicable Regional Water Quality Control Board?***

Less Than Significant Impact. Under Section 401 of the Clean Water Act (CWA) the Regional Water Quality Control Board (RWQCB) issues National Pollutant Discharge Elimination System (NPDES) permits to regulate waste discharged to “waters of the nation,” which includes reservoirs, lakes and their tributary waters. Waste discharges include discharges of stormwater and construction project discharges. In addition, the project will be required to submit a Standard Urban Stormwater Mitigation Plan (SUSMP) to mitigate urban storm water runoff. Prior to the issuance of building permits, the project applicant will be required to satisfy the requirements related to the payment of fees and/or provisions of adequate wastewater facilities. Because the project will comply with the waste discharge prohibitions and water quality objectives established by the RWQCB, impacts are considered to be less than significant.

Mitigation Measures: No mitigation measures are required.

2) ***Require or result in the construction of new water or wastewater treatment facilities or expansion of existing facilities, the construction of which could cause significant environmental effects?***

No Impact. The proposed project would result in an increase of 20 new residential dwelling units. However, this increase is not anticipated to substantially increase the demand for new water or wastewater treatment facilities or the need to expand existing facilities. The project site is presently served by existing facilities. No impacts would occur.

Mitigation Measures: No mitigation measures are required.

3) ***Require or result in the construction of new storm water drainage facilities or expansion of existing facilities, the construction of which could cause significant environmental effects?***

Less than Significant Impact. As indicated in Response R-2 above, the project involves a net increase of 20 residential dwelling units. The project is not expected to result in a significant increase in the amount of runoff, since the site is currently developed, and the new project will span across the site, except for the existing two residential units and garage to be maintained, and the area surrounding these structures. Runoff from the project site would be conveyed via streets and gutters to storm drain locations around the project site. The proposed project's slight increase in runoff would not require any substantial changes to the existing drainage pattern of the site or the area, nor would it affect the capacity of the existing storm drain system. Therefore, no significant impacts would occur. .

Mitigation Measures: No mitigation measures are required.

4) ***Have sufficient water supplies available to serve the project from existing entitlements and resources, or are new or expanded entitlements needed?***

Less than Significant Impact. The proposed project involves the development of a 25-unit affordable housing project resulting in an increase of 20 units to the project site. The new project must comply with the provisions of Glendale's Mandatory Water Conservation Ordinance (GMC

13.36), as well as the California Green Building Standards (CALGreen) of the Glendale Green Building Code and the water conserving fixture and fittings requirements per the current California Plumbing Code. All new buildings must utilize higher efficiency plumbing fixtures (low-flush toilets, low-flow showerheads and faucets) and automatic irrigation system controllers based on water or soil moisture, and demonstrate an indoor net reduction in the consumption of potable water; such plumbing fixtures and fittings that will be much more efficient than that of the existing housing currently on the project site. Furthermore, landscaping for the project will require the use of drought tolerant plantings and the existing lawns would be removed. Consequently, this impact is considered to be less than significant.

Mitigation Measures: No mitigation measures are required.

- 5) **Result in a determination by the wastewater treatment provider, which serves or may serve the project that it has adequate capacity to serve the project's projected demand in addition to the provider's existing commitments?**

No Impact. See response provided under Section R-2.

Mitigation Measures: No mitigation measures are required.

- 6) **Be served by a landfill with sufficient permitted capacity to accommodate the project's solid waste disposal needs?**

Less Than Significant Impact. Solid waste generation is expected to increase during the construction phase of the project, as well as when the future residents move into the residential units. However, the existing solid waste system would be sufficient to accommodate wastes generated during construction. No significant impacts to solid waste facilities are anticipated to occur as a result of the proposed project.

Mitigation Measures: No mitigation measures are required.

- 7) **Comply with federal, state, and local statutes and regulations related to solid waste?**

No Impact. The proposed project will comply with all federal, state, and local statutes and regulations relating to solid waste. All construction debris will be disposed of according to applicable federal, state, and local statutes. No impacts would occur as a result of the proposed project.

Mitigation Measures: No mitigation measures are required.

Less Than Significant Impact. The project site is currently developed and located within an urbanized area in Central Glendale, just west of the Downtown Specific Plan area. No biological species or habitat for biological species exists on site or within the project vicinity. In addition, no Habitat Conservation Plan, Natural Community Conservation Plan, or other approved habitat conservation plans apply to the project site. As such, the proposed project would not have the potential to substantially reduce the habitat of fish or wildlife species, cause a fish or wildlife population to drop below self-sustaining levels, threaten to eliminate a plant or animal community, or reduce the number or restrict the range of a rare or endangered plant or animal. Furthermore, the proposed project would not have the potential to eliminate important examples of major periods of California history or prehistory, including historical, archaeological, or paleontological resources. Potential impacts to historical resources will be fully mitigated. Therefore, the proposed project would not result in significant environmental impacts that have the potential to degrade the quality of the environment. No significant impacts are anticipated.

Less Than Significant Impact. Cumulative impacts may occur when the proposed project, in conjunction with one or more related projects, would yield an impact that is greater than what would occur with the development of only the proposed project. With regard to cumulative effects for the issues of agricultural, biological, and mineral resources, the project site is located in an urbanized area and therefore, other developments occurring in the area of the project would largely occur on previously disturbed land and are not anticipated to have an impact. Thus, no cumulative impact to these resources would occur. Impacts related to archaeological resources, paleontological resources and hazards and hazardous materials are generally confined to a specific site and do not affect off-site areas.

- 3) ***Does the project have environmental effects which will cause substantial adverse effects on human beings, either directly or indirectly?***

Less Than Significant Impact. Based on the analysis presented above, implementation of the aforementioned mitigation measures would reduce environmental impacts such that no substantial adverse effects on humans would occur.
