In no case will the incentive exceed the value of saved energy over the life of the installed measures assuming \$0.06 per kilowatt-hour saved. **The total incentive issued to a customer during a given fiscal year cannot exceed \$100,000. Additional guidelines apply, such as cost effectiveness tests and funding availability. Projects must be completed within 90 days of reservation. All requests are subject to GWP review and approval. This program may be modified or terminated without prior notice and is provided to qualified customers on a first-come, first-served basis until program funds are no longer available.*

I have provided truthful and accurate information to document project costs and estimated annual demand and energy savings.
