**LOCATION:** 129 – 133 WEST LOS FELIZ ROAD  
**APPLICANT:** Rodney V. Khan/Khan Consulting  
**ZONE:** “C3” - (Commercial Service) Zone, Height District I  
**LEGAL DESCRIPTION:** Lots 18 and 19, Block 2, Vine Cottage Tract

**PROJECT DESCRIPTION**

**An application to construct an approximately 57,350 square-foot, five story medical congregate care facility on an approximately 17,700 square-foot site. The first level includes a lobby, dining room, kitchen, pharmacy and administrative areas. The second through fifth floors mimic each other and include 18 rooms and common sitting areas. A roof deck is also proposed. A ramp leading to the subterranean garage is located off of the driveway in the western portion of the site.**

**ADMINISTRATIVE EXCEPTION  
CODE REQUIRES**

(1) In the C3 Zone, Height District I, the maximum building height is 50 feet.

**APPLICANT’S PROPOSAL**

(1) An administrative exception to allow a 60-foot high building, which is a 20% deviation from the numeric standard of maximum building height.

**VARIANCE  
CODE REQUIRES**

(1) In the C3 Zone, Height District I, the maximum number of stories is three.

**APPLICANT’S PROPOSAL**

(1) A variance to allow a five (5)-story building.

**ENVIRONMENTAL DETERMINATION**

The Community Development Department, after having conducted an Initial Study, has prepared a Negative Declaration (ND) for the project.
