Project Characteristics - 1) 3-story 35,000 square-foot residential congregate living/medical facility with 79-beds, a 32 space semi-subterranean parking garage.
 2) 36,780 square-foot parking garage (one level subterranean and two levels above grade) with 110 spaces on a 64,495 square-foot site consisting of three lots

Land Use - The project site consists of 3 lots: 24,030 sq. ft., 5,780 sq. ft. and 35,600 sq. ft. (65,410 sq. ft. combined). The 35,000 sq. ft. residential congregate living, medical facility will consist of 79 beds with a one-level subterranean garage with 32 parking spaces. A new three-level (one level subterranean and two levels above grade) parking structure with 110 parking spaces is proposed at other portions of the site.

Grading -

Construction Phase - Grading (all export): Approximately 8,000 cubic yards during Phase II and approximately 6,110 cubic yards during Phase III (14,110 cubic yards total). Approximately 500 truck trips during Phase II, and approximately 382 truck trips during Phase III (16 cubic yards per truck for a total of 882 truck trips). Grading would not occur over the entire 103 week period, but would be concentrated over approximately three weeks within the first eight weeks of both Phases II and III.
