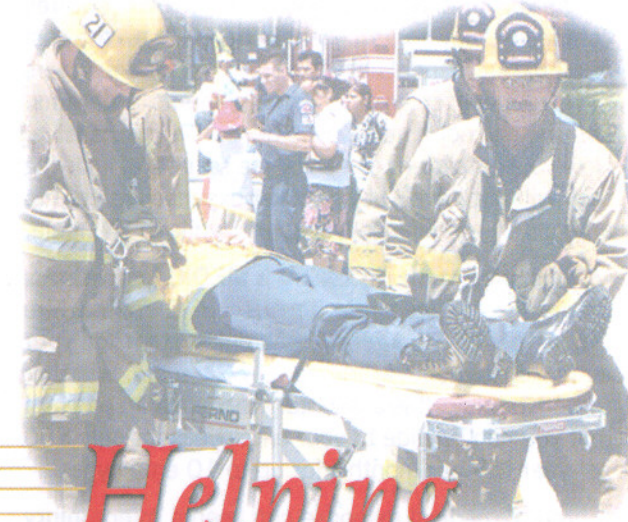

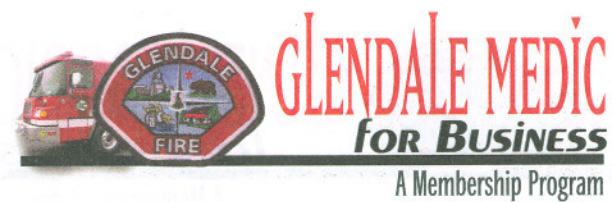

patient assessment and transportation from any location in Glendale to a medically appropriate local area hospital.

There is no guarantee that the patient's insurance will cover all of the charges; some may be denied or only partially paid, resulting in an unpaid balance for which the patient is responsible. As a **GLENDALE MEDIC for Business** member with insurance, your employees will not have those worries because they will not be responsible for any out-of-pocket costs. If the patient has medical insurance and/or Medicare, no payment will be required from the employee; however, their insurance and/or Medicare will be billed. ***If they do not have any medical or vehicle insurance, they will receive a 50% discount on their emergency ambulance bill.***

***Is non-emergency ambulance transportation covered to or from a hospital, doctors' office, rehabilitation facility or retirement home?***

The Glendale Fire Department provides emergency 911 medical responses only. There are several private ambulance companies that can provide non-emergency medical transportation if needed.

***How are members identified?***

No membership card is required. You provide us with your employee names and date of hire, and we will compare the patient's name against the information you provided. Verification of continued employment will be requested from you when we receive a claim.

***How do I Join GLENDALE MEDIC for Business?***

Complete and submit the **GLENDALE MEDIC for Business** application to begin the process. Upon approval of your completed application, you will receive a letter indicating the terms of coverage. For your convenience, the cost of your business's membership will be placed on your Glendale Water & Power utility bill, at a rate of \$5 per month, or \$10 for those accounts billed bi-monthly. This is for up to ten employees. For each additional ten employees, the charge is \$24 dollars per year billed



at \$2 per month. If your business changes locations in Glendale, simply inform us of the change and we will transfer your membership.

## ***INTRODUCTION***

Attracting and keeping good employees requires competitive pay and excellent benefits. With the cost of employee benefits skyrocketing, many employers have reduced or dropped their benefits programs. Fortunately, not all employee benefits are expensive. Now your employees can enjoy the security of knowing they will not have out-of-pocket expenses related to emergency ambulance transports while in Glendale.

Membership in the **GLENDALE MEDIC for Business** program provides unlimited use of Glendale Fire Department's emergency medical system for your employees whenever they are in Glendale, whether at work or play. It is a voluntary membership program that you can provide to your employees for only \$60 per year (\$5 per month!) for up to 10 employees.

A prompt medical response can keep a minor injury from escalating into a major problem, resulting in lost time and productivity. Co-payment or deductibles on medical insurance policies can cost as much as \$240 for a single ambulance transport. With **GLENDALE MEDIC for Business**, you and your employees can call for an ambulance, without concern for out-of-pocket expenses.

***Who is covered by GLENDALE MEDIC?***

Any "enrolled" employee of your company who requires emergency ambulance transportation to a hospital is covered. An "enrolled" employee is defined as an individual who is either a full time or part time employee and whose base of operations is in Glendale.

***What does the membership cover?***

The **GLENDALE MEDIC for Business** fee covers charges for emergency medical services and supplies provided by the Glendale Fire Department, including
