The Solar Schoolhouse Program provides solar energy education opportunities to Glendale teachers by providing professional development workshops, classroom

materials, project development, and classroom assistance towards the goal of increasing solar literacy. Over 100 teachers have attended workshops and have received up to \$1500 in solar classroom teaching materials to continue teaching about solar energy.

On Wednesday, February 19, GWP held a free Solar Battery Charger Workshop at the Glendale Central Library as part of the Solar Schoolhouse program. The workshop provided materials for attendees to build their own solar charger which can be used for cellphones, power banks, and lights in emergency situations. Mayor Najarian and Councilmember Agajanian welcomed attendees to the workshop and expressed their support for GWP's Solar Schoolhouse program.

**GWP Takes Steps Towards A More Sustainable Future**With Two Upcoming Renewable Projects

## **Solar Energy**

GWP's commitment to a reliable and sustainable future took a leap forward earlier year. We entered into a 25-year agreement with the Southern California Public Power Authority (SCPPA) to provide Glendale with a 12.5% share of renewable solar energy, battery storage, and other environmental attributes from the Eland Solar and Storage Center in Kern County. GWP will receive approximately 25 MW of renewable solar energy and 25 MW/50 MWH of battery storage as part of the agreement.

"This project will be the largest solar and battery energy storage project in the United States, and Glendale is proud to be part of it," said Glendale Mayor Ara Najarian.

We look forward to reaping the benefits of the Eland project and to continue in our efforts to increase our renewable energy portfolio for a greener and cleaner future.

## **Geothermal Energy**

At the February 26<sup>th</sup> meeting of the Glendale City Council GWP was granted approval to enter into a set of long-term Power Sales Agreements (PSA) with the Southern California Public Power Authority (SCPPA) to purchase geothermal energy. The projects under the management of Open Mountain Energy, LLC located in Nevada, will commence on April


2020 and April 2021 respectively.

The two projects combined will bring 15.5 MW of 100% renewable energy to Glendale and our GWP customers, and move us significantly further towards meeting the State mandates of SB 100. The projects will equate to an 11% increase in our Renewable Portfolio Standard (RPS) and reduce our carbon emissions by 52,600 metric tons per year. This geothermal energy is consistent and has a high capacity availability at approximately 80% as compared to the intermittent nature of solar and wind at 25% and 34% respectively. This project marks yet another successful milestone for the City of Glendale and GWP in reducing our use of fossil fuels and in bringing environmentally sustainable, reliable and affordable energy alternatives to our customers. 
## Do Time-Of-Use Rates Make Sense For You?

Take control of your electric bill by switching over to Time-Of-Use (TOU) rates. TOU rates allow you to reduce your electricity expenses by shifting your energy usage to off-peak hours. Rates during off-peak hours are lower than rates during peak hours, allowing you to save money. TOU rates may benefit you if you can shift most of your electricity use to before noon or after 9:00 p.m. This includes using major appliances during this time and charging your electric vehicle overnight. Below is the chart showing the current TOU rates for residential customers.
