## **PROJECT DESCRIPTION**

Application for an Administrative Use Permit (AUP) to allow the continued on-site sales, service and consumption of alcoholic beverages (ABC License Type 47) at an existing full-service restaurant (Hookah Lounge) located in the C3-I (Commercial Service) Zone.

#### **CODE REQUIRES**

1) The sales, service and on-site consumption of alcoholic beverages requires an Administrative Use Permit in the C3-I Zone (Chapter 30.12.020, Table 30.12.-A).

## **APPLICANT'S PROPOSAL**

1) To allow the continued sale of alcoholic beverages for on-site consumption at an existing full-service restaurant.

### **ENVIRONMENTAL DETERMINATION**

The project is exempt from CEQA review as a Class 1 "Existing Facilities" exemption, pursuant to State CEQA Guidelines Section 15301(e), because the discretionary permit request is a renewal to allow for the on-site sales, service and consumption of alcoholic beverages at an existing full-service restaurant within an existing commercial space and there is no added floor area proposed.
