VFCC updates:

- Ambrose and Galstyan will attend the IAFC Tech Conference next week in Texas.
- CAD/Operations: We are currently behind on version updates, and the latest version is in our regression tests. Our previous regression tests found critical performance issues, including an issue with the Tablet Command interface. Peraton has given mid-November as the release date for the updated version, which will again require testing. In the interim, we are moving forward with the Table Command onboarding.
- Staffing: Two are still in backgrounds for FCO recruit. Cheryl Mendez has accepted the Center Manager position at BRK PD. We are sad to see her go, but the good news is that she will be close by and may still work shifts on a PT basis. We will be working on new recruitment to finish filling vacancies.
- Tech:
 - Paging – As reported at the last task force and in the AM report, we had experienced problems with the paging system. The vendor-related issues have mostly been fixed, although if you are experiencing an isolated case, please report it to Verdugo. You will notice changes to how the pages are delivered, which is out of our control.
 - Upcoming Tech Committee meeting, several agenda items which include: hardware upgrade/migration, DR site, cloud-based 911 phone lines, connectivity proof of concept, and version testing/tablet command.

Finance/Data: Gor reported that six cities will be up for contract renewal in 2023 and one in 2024. The amendment process has been streamlined, and Gor will reach out at the beginning of next year. Gor also gave a presentation on the dashboards and an update on connecting ePCR data with the CAD data.

GIS: Please submit any maps/pre-plans you would like to have available on Tablet Command. Oscar has been working with Peraton on two major GIS issues with the CAD. VFCC will be meeting this week for our bi-weekly call with PHX, SAC, and Escondido to compare progress on CAD issues.

Task Force Meeting Minutes - October 11, 2022

Workgroups: (request for volunteers, contact any workgroup member)

1. **Communications Plan** – The radio group confirmed changes to the talk groups. However, this change will also require new equipment in Verdugo. We have investigated the changes needed in our recording service and budgeting for the latest equipment. Another meeting is planned with members of PAS to discuss the Operations changes in the current plan. The plan would launch the com plan at the greater alarm and, with the talk group changes, ensure repeated frequencies.
2. **Mayday/RIC** – Chief Brown could not attend but reported that the RTG had made some final recommendations. We will be meeting to incorporate changes to add to the VFCC SOG.
3. **QI** – Gor presented the recent data (attached). Based on the review, the removal of transport on initial dispatch for DOWN, TC, and ASLT has been successful. Gor has reported detailed numbers to Chief Sell and Chief Hansen for PAS review. Verdugo will produce an opt-in document for each agency to participate in ePCR/CAD data sharing. This will allow comprehensive QI/QA for VFCC and help our agencies better deploy resources.
4. **Emerging Tech** – Ambrose reports that Tablet Command onboarding is in process. Chief Suen and Chief Ambrose have been attending the Firescope EIT work group meetings. They will have an update after the December in-person meeting. The group has been working on dismounted firefighter tracking and tech interoperability. CA OES will give a presentation/update on SCOUT at the IAFC conference.

Old Business:

- Standards of Command training – Ambrose reports that 3rd quarter training was a success thanks to Chief Inman and Chief Rueda. Over 15 persons registered each day, with more who attended 'off roster.' The feedback from attendees was very positive. 4th quarter training on 'Standards of Command' will be sometime in November. We will also need to conduct Tablet Command training. SNM will be reaching out to BRK, standby for dates.
- Tablet Command Onboarding, as mentioned in the VFCC report, is ongoing. Please answer any emails related to collecting information on your tablets etc.
- VFCC continues to explore two-way tablet command and plans to keep it on our roadmap as an option in place of MDT's.
- Advanced (Tiered) Dispatch – Dr. Loza reported on her meeting with Chief Augustin and Chief Ambrose on EMD, tiered dispatch, taking a deeper look at type codes, training, and the RN educator for VFCC. GFD is currently looking at UCLA to provide an RN educator for which VFCC would obtain a portion of those services for training, QA/QI. Dr. Loza explained the BLS responses set up for GLN and that she would be happy to discuss any changes desired by other cities.

New Business:

- PSAP meetings. Please encourage your PSAPs to attend the monthly PSAP meeting with VFCC on the 4th Tuesday of the month at 10 AM. The meetings are a way for our primary PSAPs to check in with VFCC, address issues, and discuss staffing and any concerns.
- Power BI/NFIRS/ePCR – Gor Galstyan gave a presentation on the current data and continues to assist those who need help getting up to speed with Power BI. There is one remaining City using mySidewalk – this data is pulled monthly from CAD by Jason Pfau.
- Discussion on SOG change to update the wording to add USAR on initial dispatch for a vehicle on a person. Feedback from the group included having the Captain or BC add the USAR rather than the delays in initial dispatch. OPS committee will review the SOG for changes. Expect that USAR would 'not' be added on initial unless the circumstances involve a large vehicle. First in and BC should be adding specialty resources where expected.
- Great American Shake Out, 10/20/22 at 1020AM. Verdugo will be participating; it will be up to individual agencies on the extent of their involvement. Information will be sent with the AM report for the days before the shake-out.
- Chief Hatch suggested we revisit the command worksheets, and we will add this to the November agenda. Additionally, with the TC roll out we will need to select the TC digital command sheets.

Significant Event Review:

Three 3A fires (one with fatality) since last task force meeting.

Wheeler IC ARC, Olympic IC MTB, and Garfield IC, MPK. No IC's were present so all were generally reviewed, including lessons learned from the VFCC generated 'major incident report' review.

Roundtable:

GLN: New fire chief, Tim Ernst, started 4 weeks ago. Many areas being looked at and we anticipate good changes ahead for the GFD. We have an academy graduation on 10/20 with 11 recruits.

PAS: FF Trainee academy graduating next Thursday with 15 recruits. We are knocking out driver operator 1A and they will complete their FF2 testing before they hit the floor.

MTB: Short staffed but looking to test in all ranks.

SGB: Seven recruits to the floor 2 ½ weeks ago. Captains exam coming up in November, Engineer in January. SGFF just received a new contract.

ALH: No report

MPK: No report

SMD: No report

MRV: Just hired one firefighter. We also have two paramedics that will be hitting the floor soon.

SPS: Staffing continues to be an issue with long term vacancies. AU81 is often not staffed which impacts AU28/Area C.

SNM: Chief Zanteson reported that Chief Rueda is now acting City Manager. There are a couple of rookie FF's although staffing may preclude strike team participation.

BRK: Completed BC exam with three outstanding individuals on the list. Engineers test next week. We will have three PM interns, our own personnel, and four in PM school to keep up with PM staffing. Would like to set up a meeting with VFCC to move to hi-rise response similar to PAS. Chief Hatch also requested the command sheets (added to next agenda also).

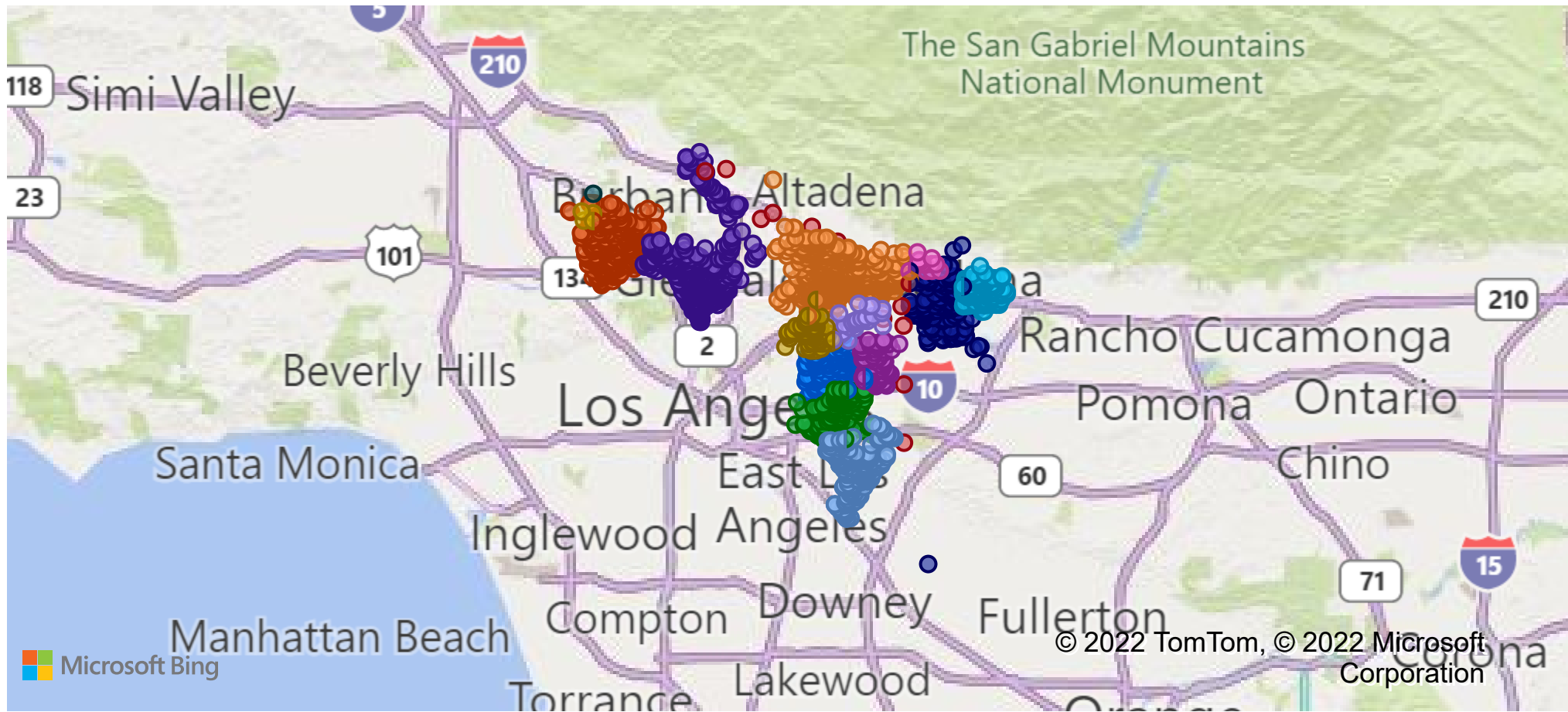

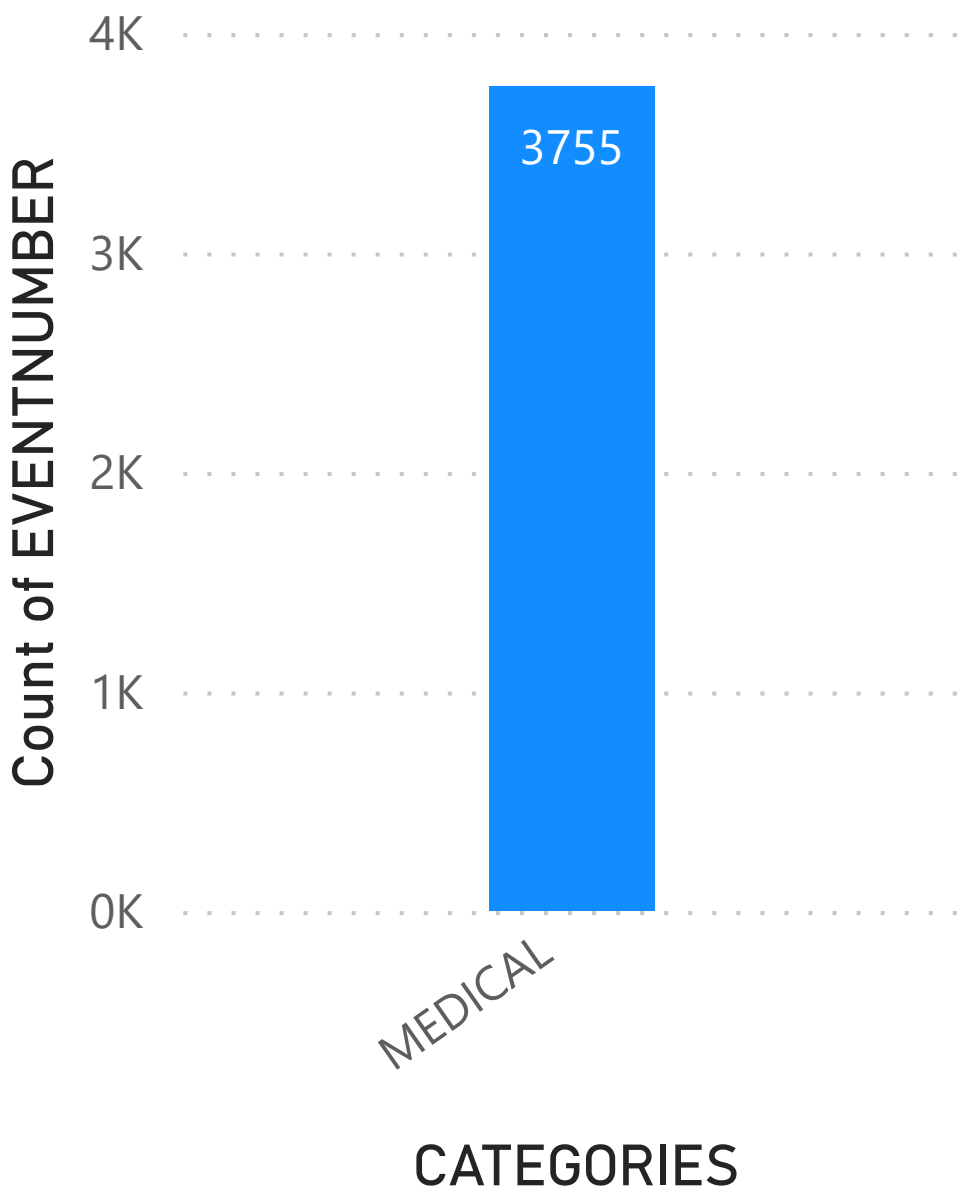


VFCC Live Data Is Published to the Dashboard Daily At 9 AM.

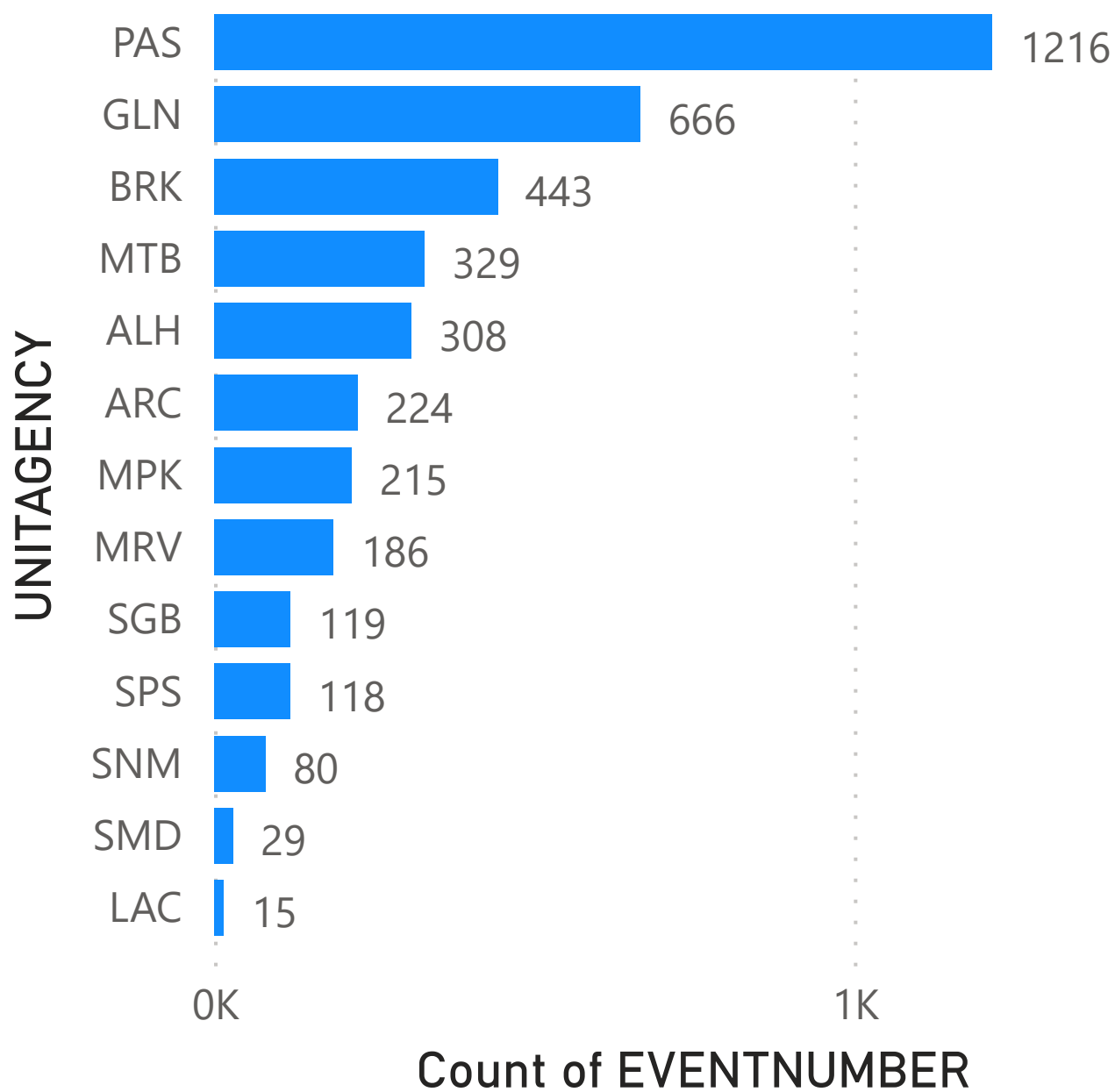
