## **PROJECT DESCRIPTION**

Design Review application to construct a new 40,240-square-foot, five-story, 31-unit, affordable rental housing project with a single concession to Government Code Section 65915 and GMC Section 30.36 (Density Bonus Incentive) with three units being reserved for very low income households. Parking would be provided in a 16-space one-level subterranean garage.

The project site is zoned SFMU (Commercial/Residential Mixed Use) and developed with two residential buildings (1642 South Central Avenue and 1608 Gardena Avenue) and a detached garage. The residence located at 1642 South Central Avenue was constructed in 1913, and a second residence located on the same lot but addressed on 1608 Gardena Avenue was constructed c.1923. The project proposes to demolish both residential dwelling units and the garage.

Draft Environmental Impact Report (DEIR) was circulated June 10, 2021, through July 12, 2021 for a 30-day review period.
