

City of Glendale Workplan FY 2022-23

INTRODUCTION

The City of Glendale held a City Council governance workshop in the form of a Special City Council meeting on November 6, 2021. The workshop provided an opportunity for members of the City Council to develop a shared understanding of high-performance governance best practices, discuss norms, establish priorities for the next budget year, and strengthen teamwork and leadership skills.

As part of the priority setting discussion, the following four areas were identified by the City Council:



Following the November 6 meeting, City staff prepared a workplan that identified projects, programs and initiatives beyond the normal workload, designed to carry out the Council's four highest priorities as highlighted above.

The City Manager presented the draft workplan to Council on December 7, 2021, at a public meeting. After review and discussion, Council members provided additional projects and initiatives they wanted to be incorporated into the workplan. Council further directed staff to incorporate said priorities and workplan into the preparation of the 2022-23 Fiscal Year Budget. This document represents the final workplan.

- 1. Complete Climate Action & Adaptation Plan. (MSD)
- Clean/Renewable Energy Development, Investments & Purchase Agreements. (GWP)
- 3. Identify and develop local solar energy storage at a minimum of 2 City-owned properties. (GWP)
- 4. Establish fuel crew to mitigate threat of wildfires around GWP & City infrastructure (GWP/FD)
- 5. Plant 1,500 new trees to increase tree canopy from 21% to 25% over the next 10 years. (PW)
- 6. Regulate the use of single use plastics for food service providers in order to reduce litter. (MSD)
- 7. Develop a "reach code" (above & beyond CA Energy Code) for electrification of new building construction. (MSD)
- 8. Conduct public outreach and implement organics diversion and compliance requirements. (PW)
- 9. Explore distributed energy resources (DER). (GWP)
- 10. Assess City owned sites for feasibility of installing solar panels. (GWP)
- 11. Pilot cool surface/pavement on Lot #2. (PW)
- 12. Develop a policy discussion and potential ordinance to ban gas-powered leaf blowers and other landscape equipment Citywide. (CDD)
- 13. Replace City-owned gas powered hand held equipment to electrical. (CSP)
