Strategic Aim 1: **Evaluate & Assess**

Goals:

- Assess issues and needs confronting all women and girls in Glendale
- Evaluate and identify gaps in existing services/resources in the community on an ongoing basis
- Recommend and support programs that further the goals and mission of the Commission

An in-depth understanding of the status and well-being of women and girls in our community is foundational to effectively serving our diverse community and to making informed recommendations to City Council. By identifying existing resources, the Commission seeks to advance its mission and increase access to those resources for women and girls who need them. The Commission maintains a continuing assessment of the issues and needs confronting women and girls in Glendale. Together, gathering existing information and identifying existing resources permits the Commission to make recommendations and support programs that further the goals and mission of the Commission.

Strategic Aim 2: **Policy Development, Advocacy & Advising**

Goals:

- Recommend to City Council policies and issues relevant to the status, success, and prosperity of women and girls in Glendale
- Advocate for policies relevant to the status of women and girls in Glendale

As an advisory board to City Council, one of the primary functions of the Commission is policy recommendation. The Commission is committed to being informed about current and impending issues, policies, and legislation relevant to the well-being of women and girls in Glendale in order to make recommendations on such issues, policies, and legislation to City Council. As part of this function, the Commission also monitors legislation on the state and federal levels that impact and affect women and girls, and advises and advocates on these issues as appropriate.

Strategic Aim 3:

Communication & Education

Goals:

- Increase the level of knowledge in the community regarding women's and girls' issues and the well-being of women in the community
- Maximize awareness of services and resources available for both women and girls
- Work with City agencies to publicize the Commission's work as it relates to the status and well-being and prosperity of women and girls in Glendale

Providing resources and education to the community is an important public service offered by the Commission. The Commission demonstrates its position as a significant leader in women's issues by convening quarterly Commission meetings to address key women's issues. The Commission is inclusive in speaker and audience outreach, inviting community groups and organizations to present information and services offered to the community. The Commission educates the community about its work through the City website (glendaleca.gov/women), which provides access to information, services, and resources relevant to the needs of women and girls. The Commission also makes informational materials on issues relevant to women and girls available at City and community venues.

Strategic Aim 4:

Community Partnerships & Outreach

Goals:

- Review existing partnerships and identify potential new partnerships to further the goals and mission of the Commission
- Build alliances and network with other organizations to further the goals and mission of the Commission
- Maintain visibility within the community to promote the well-being of women and girls and to raise the profile of the Commission's work
