To construct an approximately 406,318 square feet of building area consists of an above-grade six-story parking structure and three commercial buildings that contain ten (10) production soundstage studios, three flex spaces, production offices, commissary spaces, parking lots, and various support spaces on an approximately 424,453 square feet (9.74 acres) site, located in the IMU zone (Industrial/Commercial Mixed Use). The project will demolish all existing warehouse and commercial buildings and related parking areas, built between 1947 and 1989.
