2. Review/Approval of Minutes from November 8, 2023 Meeting

Minutes were approved without amendment or objection.

3. City Portfolio Overview December 2023

The City Portfolio finished the second fiscal quarter ending December 31, 2023 with an average balance of \$989 million, down \$5 million from \$994 million at the end of the previous quarter.

Interest earnings for the months of October, November, and December were \$2,384,266, \$1,452,318, and \$2,055,718 respectively; for a total of \$5,892,302 or \$36,525 down from the \$5,928,828 earned last quarter.

The quarter ended with a rate of return at 2.92% which is 20 basis points up from the previous quarter.

The City Treasurer indicated that the office opened a California Asset Management Program (CAMP) account. The return on this liquid pooled investment option is at 5.5%. Some of the funds from the LAIF (Local Agency Investment Fund) accounts were shifted to the CAMP account since LAIF was paying 3.5%. The City Treasurer also indicated that the LAIF account will remain open in the event their rate goes up.

4. Portfolio Report December 2023

The City Treasurer went over the report which included the December 2023 Portfolio Summary (which is the last month at quarter end), Distribution by Portfolio Name, Distribution by Security Type, and Transaction Summary by Action.

5. Distribution by Portfolio Name

This report showed the two types of investments, fixed and liquid assets. This page also showed two pie charts that represented the participation percentages of all three portfolios reflecting portfolio holdings as of September 30, 2023 and December 31, 2023.

6. Distribution by Security Type

This page showed two pie charts that represented the Portfolio holding distribution by asset category – quarterly comparison for September 30, 2023 and December 31, 2023. The City Treasurer indicated that there was not much change in the distribution since the purchases made were relatively the same such as Federal Agencies and Treasury Notes.

7. Transaction Summary by Action

This page contained the City's investment activities during the quarter (i.e., purchases, maturities, interest/dividends, deposits and withdrawals). This portion of the report also includes security information such as the settlement date, CUSIP, portfolio's par/face value, security description, purchase principal, and yield-to-maturity (YTM) @ cost. The City Treasurer indicated that most of the transactions shown in the Transaction Summary by Action section were the transfers between the LAIF and CAMP accounts. The City Treasurer also indicated that the bonds that were purchased five years ago, that are now maturing, were low interest rate bonds. He is attempting to replace them with 3.5% to 4.5% bonds that will mature in five years.

8. Portfolio Holding by Asset Class

This page showed the City's portfolio holdings (i.e., corporate bonds, agency bonds, municipal bonds, treasury notes/bills, and other state obligations). This portion of the report also includes credit ratings (i.e., Moody's, S&P, etc.). The City Treasurer indicated that there were no changes to the bonds' credit ratings.

CITY PORTFOLIO OVERVIEW

The City Portfolio finished the third fiscal quarter ending March 31, 2024, with an average balance of \$984 million, down \$5 million from \$989 million at the end of the previous quarter. Interest earnings for the months of January, February, and March were \$2,798,701, \$1,616,267, and \$2,736,811 respectively; for a total of \$7,151,779 or \$1,259,476 up from the \$5,892,303 earned last quarter. The quarter ended with a rate of return at 2.90% which is 2 basis points down from the previous quarter.

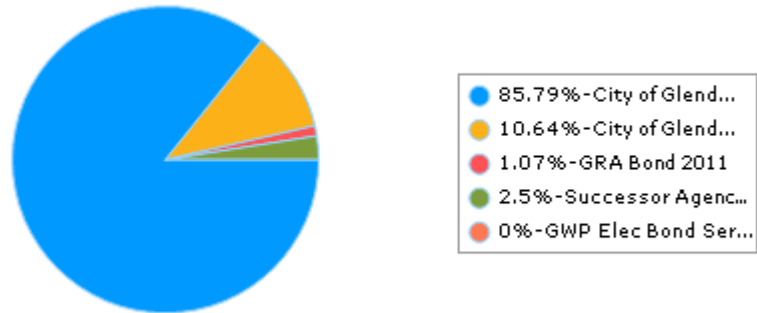

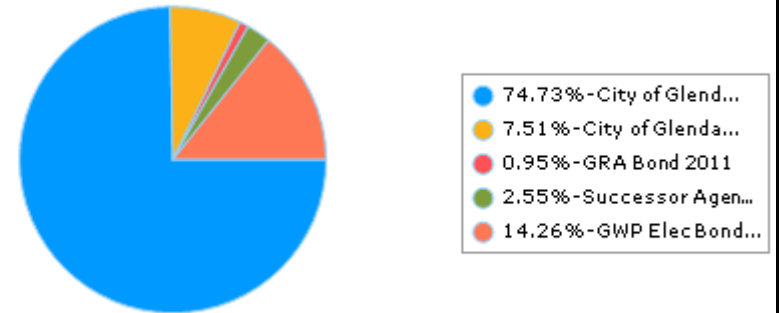

Portfolio Holdings as of 3/31/2024



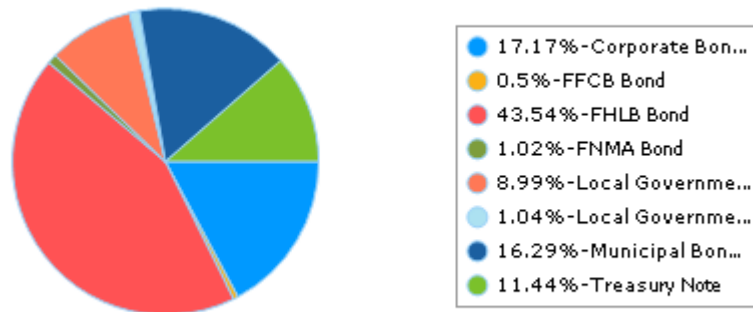

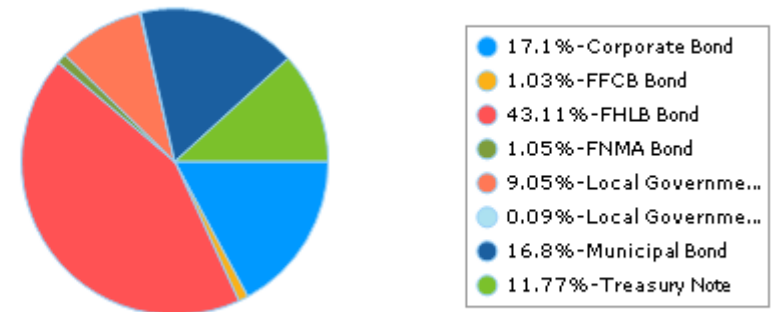
